BLUFF TRAIL, LOOKOUT MOUNTAIN, TENNESSEE 5 December, 1981

This 4½ mile trail is an easy hike with splendid views of Lookout Valley, the Cumberlands, Moccasin Bend and the Racoon Mt. Pump Storage Project. The trail starts at Covenant College, follows the mountain bluffs terminating at Point Park. Bring food and water for lunch at Sunset Rock - a short steep climb off the trail. Meet at the Point Park Visitor's Center at 10 a.m. EST. There will be a carpool to the trailhead. Coming from east or west on I-24, use Lookout Mt. exit and follow the signs to the top of the mountain.

CLEAR CREEK-RESERVOIR HILL-GRISTMILL LOOP TRAILS, NORRIS MUNICIPAL PARK

(Anderson Co.)
6 December 1981 (Sunday)

Beginning at the old Rice Mill below Norris Dam, this 3 mile Class II or III loop follows streams and hills of the Norris Watershed. Interesting features along the hike, in addition to the 18th century water powered gristmill, include an abandoned fish hatchery, underground reservoir, large trees and rock outcroppings. Meet at 10 a.m. Eastern Time at the 18th century gristmill below Norris Dam on US 441. Bring a lunch.

Reelfoot Lake State Park and Eagle Tour--(Lake County) 12 December 1981

Join the Memphis Chapter for am Eagle Tour of Reelfoot Lake. The American Bald Eagle will spend another winter around the lake. Reelfoot Lake, named for a Chief Reelfoot of the Chickasaw Nation, was created by a series of severe earthquakes during the bitter cold winter of 1811-12. The lake provides excellent viewing of the eagles and migrating waterfowl during November through March so bring your camera and binoculars. Meet promptly at 9:00 a.m. at Air Park Inn, 8 miles north of Tiptonville on Hiway 78.

CUMBERLAND GAP NATIONAL HISTORIC PARK-KENTUCKY, VIRGINIA, TENNESSEE BORDERS 19-20 December, 1981

This is a car camp at the Wilderness Road Campground inside the park and a day hike Saturday up the Chadwell Gap Trail 2.3 miles, then West along the Ridge Trail approximately 1.5 miles to the Hensley Settlement. The Hensley Settlement is a picturesque log settlement extablished in 1905 by the Hensleys and the Gibbons and preserved by the Department of Interior after it was abondoned. The last Hensley left in 1951. It is a true example of an isolated community in rural Appalachia with no electricity nor any other modern convenience.

Meet group at the check-in station, Wilderness Road Campground, 8:30 a.m. E.S.T., Saturday, December 19, 1981. Will leave for trail head at 9:00. For a car pool

Directions: I-75 North of Knoxville; then NE on Hwy. 25 W at Caryville; then ENE on Hwy. 63 at LaFollette; then N on Hwy. 25E; follow signs to Wilderness Road Campground. Sunday: Group will drive to Pinnacle Point for an overlook of the Cumberland Gap and Valley and possibly an easy walk along the Tri-State Trail to a point where the 3 states meet. Bring your camera and step back into early American History. Weather: Cold! Daytime high 50°; Night, below freezing. Possible light snow, expect windchill. Bring warm clothing and plenty to eat.

TRAIL NOTES FROM THE PRESIDENT

Our annual meeting in Crossville was a great success. Some of the ideas that evolved from our general business meeting included some real challenges for our association. Some of the highlights were:

We were challenged to take the lead in organizing a state trails council, bringing together representatives from all trail interest groups. i.e. hiking, horseback riding, water trails, bicycle, ORV trails, etc. This would give us a greater voice on vital issues, and the National Trails Council, of course, does represent all trail groups.

A committee was appointed to write a "position paper" for the Governor to let him know in detail what we expect from his <u>Safe Growth Plan</u> in the area of trail development and maintenance.

The idea was proposed that we investigate the feasibility of several outdoor interest groups coordinating their annual weekend in the fall. With TTA, Audubon, TSRA, Sierra Club, and TEC's Intergroups, etc., there are some of us going often and in different directions.

Diane Davidson gave a good report on our Adopt-A-Trail program, and that program should soon be instigated, a duty we owe to agencies who build trails for public use.

We welcomed and recognized persons from our new Memphis Chapter and hope to soon have a Jamestown Chapter.

And most important, we are accepting the challenge to take up our fire rakes and pulaskis and with our own volunteers return to work on our Cumberland Trail. Terry Bonham gave an excellent report on the Department of Conservation's progress on the northern sector, as well as progress on the John Muir and other trails. TTA plans to go back to work on the area south of I-40.

An election of officers was held and Dave Stidham will be our new President. I would like to thank each of our Board Members for their support this past year. Because of the wonderful cooperation, and outstanding work within our board, the chapters, and individual contributing members, the task of the President has gone very smoothly. Many things were accomplished; new chapters, Adopt-A Trail, new miles of trail, many successful hikes, suport or opposition on crucial legislative issues, meetings with important officials, Commissioner Howell, Jeanette Fitzwilliams, President of National Trails Council and others. The Workshop and Hike Day that we co-sponsored with TVA- Land Between the Lakes was very successful and a social service to the public that we need to pursue on an annual basis.

I wish to particularly thank our Vice-President, Newsletter Editor, and hike coordinator, Dave Stidham for the hours of work involved in those jobs. Evelyn Tretter, as Secretary and Dot Lingerfelt as Treasurer have all helped keep TTA running smoothly. I wish I had more space to thank each individual member of the board for their contribution and individual members who helped with specific tasks assigned to them. A special thanks goes to all those volunteer leaders who made our scheduled hikes possible, and do so year after year.

We are also very fortunate in maintaining a close rapport and relationship with Terry Bonham and his staff in the Department of Conservation which makes coordinating trail efforts on State lands possible.

As Vice-President for 1982, I will continue to enjoy my service with Tennessee Trails Association. HAPPY NEW YEAR !!!

BOWATERS & HIWASSEE RECEIVE TENNESSEE TRAILS

AWARD - TTA selected Bowaters Southern Paper
Company and Hiwassee Land Company (affiliates) as the recipient of the 1981 Tennessee
Trails Award given annually to a person or
organization "for outstanding contributions
to the association or for the furtherance of
trails and natural resources programs and opportunities within Tennessee." Bowaters and
Hiwassee Companies were cited for their Pocket Wilderness program under which the companies have set aside scenic forest lands in
their holdings and have built trails for
public use. Clarence Streetman, Cleveland,
TN, Company Executive, accepted the 1981
Tennessee Trails Award from Bertha Chrietzberg, TTA President, at the annual meeting in
Crossville, TN in October. David Rhyne, TTA
member and employee of Bowaters-Hiwassee, has
been a primary person in the development of
the Pocket Wilderness areas. Rhyne received
the "Bill Stutz Golden Boot", which accompanies the award plaque when a TTA member is
the honoree. The "Golden Boot" is a one year
trophy made by the late Bill Stutz of Chattanooga, from his own hiking boot sprayed with
gold paint. Stutz, one of the early members
and workers in TTA was a director of the
Association at the time of his death in 1980.
The "Golden Boot" award is presented to an
outstanding member of TTA each year in his
memory.

TRIP REPORT - Ten TTA members enjoyed a beautiful day in the Daddys Creek Gorge on November 14. Because of a deer hunt in Catoosa Wildlife Management Area, we were not permitted to hike all the way to Devil's Breakfast Table as planned. However, the rock-hop down Yellow Creek and the hike half way through the gorge made the day. Dennis Horne discovered a patch of Cumberland rosemary, an endangered plant species, in the gorge. - Stidham.

REPORT ON ANNUAL MEETING - About 40 people attended the TTA Annual Meeting at Camp Cumberland in Crossville, October 23-24. Some of the activities and accomplishments are reported elsewhere in this newsletter. Officers elected for 1982 are as follows: President - David Stidham

Several changes were made in the Constitution and By-Laws. Honorary membership award was established for non-members who contribute to the goals of TTA. For members who make significant contributions to TTA, a recognition in the form of deferment of dues was approved. Chapters may now be approved with only 5 members instead of a minimum of 10. A permanent committee to promote the Cumberland Trail was formed. Motions were passed to engage in a money raising project by selling trail related car tags, and to promote a statewide Trails Advisory Council. Workshops were held Saturday evening on trail first aid (Bertha Chrietzberg, leader) and the Cumberland Trail (David Stidham, leader). At the Cumberland Trail workshop it was agreed the TTA should assume primary responsibility for building the CT south of I-40 at Crab Orchard, and the State should continue in their activities north of I-40. This will be a major new direction for TTA, requiring lots of committment from the membership. You will be asked to help build trails, contact landowners, or even assume administrative responsibility for a section of trail between Crab Orchard and Prentice Cooper State Forest. Hikes on Saturday during the annual meeting included the Brady Mt. section of CT, and a hike to the Upper Falls at Little Piney River State
Natural Area. Chapter reports were made
by Jill Norvill (Memphis), Bertha Chrietzberg (Murfreesboro), and Diane Davidson (Nashville).

TRIP REPORT-Savage Gulf, Oct.10-11, With the fall colors at their peak, 11 TTA and 3 Audubon hikers enjoyed the beauty of the Savage. Overlooks of waterfalls, deep gorges with sheer rock bluffs, and the big trees of the virgin forest below greeted




