# Winter Cleanup

It may seem like we had a mild winter and spring is fully upon us, but there are still some reminders of the winter. These reminders are trees and limbs lying in the trails. The Big South Fork was hard hit by heavy snow and ice and most trails still are not open. On April 18, a major cleanup will be made at the Big South Fork. Announcements asking for volunteers will be made in the papers so keep an eye out. If you don't see anything about it, call the Park office at 423-569-2404. If you're thinking about using a chain saw, you have to be certified by the Park officials first, so call and find out how to go about that.

# Tax considerations

Sure you like to hike and occasionally volunteer to do something for the TTA. You might be able to take a tax deduction for expenses associated with the volunteer effort. If you are a casual volunteer, the tax benefit will hardly be worth the effort to do the extra paperwork, but you should be aware of the possibility. If the thought piques your interest, here are a few things to consider.

- The organization must be listed as a charitable organization and the Tennessee Trails Association, Inc. is listed in the IRS Publication 78. The chapters are part of the TTA.
- 2. You must itemize deductions on Schedule A and file the Form 1040. There are limits that depend on your income, other deductions, etc.
- 3. Most folk's contributions will be for "out-of-pocket expenses when you serve a qualified organization as a volunteer." IRS Publication 526 should be reviewed. For car expenses, you can deduct unreimbursed out-of-pocket expenses (gas, oil, tolls) or use the standard 12 cents per mile for 1997 (will be 14 cents per mile in 1998). You do need to perform a substantial duty and that would apply to most anyone who does trail maintenance for example.
- 4. If you contribute property, the deduction is limited to the fair market value of the property.
- 5. Records are required. The extent of record keeping depends on the type and value of contribution you make. Refer to the IRS publication for this one.

Disclaimer: I'm not a tax preparer nor accountant so don't take information here as authoritative. All this was summarized from IRS Publication 17, a very handy all purpose reference. The TTA was found as a qualifying organization on the IRS web page http://www.irs.ustreas.gov, an electronic version of Publication 78.
