The board meeting minutes from 2nd Quarter 2000 were approved with one following correction: Under Associate Organization Reports: CTC Arleen Scheller corrected the records to record that 1 mile of trail was built in the Royal Blue Wildlife Management Area by people from the National Sierra Club Service Trip. (4 miles was originally recorded in error).

DONATION (Libby Francis) TTA finance committee voted to send a \$150.00 donation in remembrance of Brian Brown. Brian was tragically killed in a biking accident on July 18th. Brian was the driving force in establishing TTA's Northwest Chapter.

TREASURER'S REPORT (Barbara Matheson) Financial reports were handed out to board members. Barbara is rebuilding the check book records into an accounting program. We have @\$19,972 in available funds. We remain in good financial shape.

ANNUAL MEETING UPDATE (Suva Bastin & J.R. Tate) The meeting is scheduled for Nov. 10th thru the 12th and will be at Land Between the Lakes. The September newsletter will have a registration form and information. Program and hike schedules are already done. All they need now is for members to sign up.

NEW TENNESSEE TRAILS BOOK Bob Brown is working on the next new revision of the Tennessee Trails Hiking Book. Members were asked to think about writing articles to submit for the hikes.

PERSONNEL VACANCIES (Libby Francis)

Tennessee Environmental Conservation Voters rep Herb Kneeland has asked for a replacement to this position. A TTA member from Nashville or the surrounding area would be good, as this position requires a lot of meeting attendance (which is held in Nashville). Herb is currently helping out in the membership area.

PERSONNEL VACANCIES CONT....

TTA auction chair – Arleen Scheller has requested a replacement to run the TTA annual auction held each year at the annual meeting. She will provide the infrastructure for the event but needs someone to coordinate the event. Donation request letters and all need to start going out September 1st. Arleen challenged each chapter to bring ten quality auction items. Also volunteers were requested to sign up for 1 hour shifts to help set up auction items, log in donations, and record and collect money for the items.

A motion was made to give 100% of the TTA auction funds from the November 2000 annual meeting to Breakaway. This motion was seconded and passed by unanimous vote. The board will make a decision each year as to how TTA auction funds will be dispensed.

CHAPTER REPORTS

Big South Fork was not represented at the board meeting.

<u>Clarksville</u> (Suva Bastin) They are having good attendance at their hikes and meeting programs. The hike schedule for July through December 2000 has been set.

<u>Columbia</u> (Todd Horton) Their next program meeting is in September and they will have Sam Reed from Montgomery Bell speak. Things are going well for the chapter.

<u>Cove Lake</u> was not represented at the board meeting. Arleen Scheller did report that they are hiking and have helped in some clean up projects.

<u>East Tennessee</u> (Harold Draper) Harold reported that the club is doing well in membership and hike participation. They are working on the Big South Fork effort for National Public Lands Day on September 23rd.

Memphis (Gloria Norrid) They have worked on the Shelby Forest bridges in July and finished 2 of 5 bridges. They will plan their 2001 hikes at the October meeting. They have a new chapter chair also – Frederick Belton.

<u>Murfreesboro</u> (Fount Bertram) They have stayed busy this summer with helping construct a trail at Edgar Evans State Park. Through the efforts of lots of volunteer from all over Tennessee a new four mile trail was completed. The chapter is currently concentrating on securing new memberships and is staying active hiking.

<u>Nashville</u> (Anne Wesley) They are currently looking at changing their meeting time and possibly the meeting location. There are some joint hikes and work days scheduled. The chapter has entered the Great Pumpkin Festival in Allardt Tennessee on October 7th. Anyone interested can join in the fun. Details are in the September newsletter. Anne had received 3 of Russ Mannings new hiking books and gave them to Jim Clark of our newest chapter in N.W. Tennessee.

Northwest (Jim Clark) They will have a chapter meeting sometime in the next week as everyone is back in school (U.T./Martin) now. They will be making plans for future hikes and events and continue to have faculty support in the chapter.

<u>Plateau</u> was not represented at the board meeting. Leigh Jones did report however that they have planned the rest of their hikes for 2000. They do not hold regular meetings in the summer, but will resume meetings again in September.

Upper Cumberland was not represented at the board meeting.

ASSOCIATE ORGANIZATION REPORTS

CTC (Rob Weber reported for CTC) CTC meeting minutes from July 29th and a Balance Sheet as of June 30th were handed out to board members. They did get the state contract and Lindhurst Foundation match so they are in good financial shape through @July 2001. On August 25th they will hold a Black Mountain Fundraiser kickoff at Cumberland

Mountain State Park.

Tennessee's Millennium Legacy Trail (Arleen Scheller) Arleen handed out invitations for the CT's national designation as Tennessee's Millennium Legacy Trail. Governor Sundquist plans to attend the celebration which is Friday Sept. 15th and Saturday Sept. 16th. Lots of music, hikes, and celebrating to take place. Arleen requested TTA to sponsor part of the cost of this event. A motion was made and seconded by the board for TTA to write a check for \$500.00 towards the event cost.

Rob Weber approached the TTA board to make a commitment to assist with establishing the Kentucky Trails Association (KTA). A motion was made and seconded by the TTA board to adopt a position that we're in favor of KTA and as an organization we'll do what we can to further KTA. We will also urge our respective chapters and individuals to further KTA any way they can. Libby will appoint a committee to further explore the forming of KTA.

TRAC (Jim Pascoe) TRAC is undergoing many transitions at this time. They are redefining their goals and leadership. They currently have a web site also. Rob Weber has offered to get with TRAC leaders and offer organizational help and information if they so desire. Penny Brooke was present at the board meeting and gave a slide show and shared information regarding raising funds for expanding the Cumberland River Bicentennial Trail section. This is the trail that helped to start TRAC. Donation forms were passed out. They need to raise @\$36,000 more by December 2000 to secure the land. An Evans Means grant form was also given to Ms. Brooke to submit for funding.

East Tennessee Regional Rep (Arleen Scheller) Arleen will follow up with contacts regarding a new northeast chapter in the Kingsport area.

Middle Tennessee Regional Rep (Barbara Draude) Barbara reported that there was not any new information or contacts at this time.

<u>Evan Means Grant Brochures</u> (Libby Francis) The new brochures are complete and ready to hand out. There will be an announcement in the next newsletter letting everyone know.

National Public Lands Day (Harold Draper) Saturday September 23rd is National Public Lands Day. 

- The meeting was held at the Cumberland Cove Welcome Center and was called to order at 8:40 a.m. I. Introductions were made.
 - A videotape was shown made by Michigan State University during their attendance at our Spring 2000 BreakAway program.

II. Announcements

- Rob Weber stated that the Cumberland Trail Conference is in the process of interviewing for a full-time Program Coordinator. This person will be responsible for program coordination and leadership, as well as trail development and maintenance. It will be necessary to shift Arleen's focus towards the upcoming Capital Campaign; therefore, someone to coordinate our trail programs is an absolute necessity.
- Sandra Spearman stated that the Cumberland Trail website now has an official registered domain name: www.cumberlandtrail.org...make a note of it! Our previous website address will continue to be operational during this transition with a link or "pointer" directing visitors to our new website.

III. Organizational

Rob Weber reviewed a CTC organizational overview chart and discussed the roles and responsibilities of the CTC Council Chairman. A Council Chairman is needed as we progress towards the capital campaign. Council reorganization, as well as bylaws, roles, and responsibilities will be established in the upcoming months of the capital campaign. Sam Powell was nominated to fill the chairman position.

Motion: A motion was made, seconded, and approved to elect Sam Powell as our CTC Council Chairman.

- Susan Weber reviewed the Profit and Loss Report and Balance Sheet for January June 2000. The April-June (2nd quarter) CTC progress report was included in individual packets.
- Arleen Scheller gave a Grants Overview for January June 2000. In addition to reviewing the grants received, she reported on the outstanding grants and their descriptions of use, as well as our funding needs for the remainder of 2000. Grants awarded totaled \$13,350 with grants in progress totaling \$60,385.

IV. Old Business

- Arleen reported that the CT Auction 2000 was a big success. We netted \$15,316.59 to kickoff the PPPN capital campaign. It is proposed that the next auction take place in May, possibly in Chattanooga.
- A draft of the invitation for our Millennium Legacy Trail event was handed out. The event will take place on September 15th at 11:00 a.m. at Nemo Bridge. Attendees will be shuttled to the site from the Obed WSR office. Hike leaders are still needed on the shorter hikes. Governor Sundquist and Justin Wilson have been confirmed. The Secretary of Transportation and the Secretary of the Interior may also attend. A \$2,400 budget has been established for this event. Sponsors are being obtained.
- A Park Ranger, Bobby Fulcher, has been assigned to the Cumberland Trail State Park. Bobby has been
 with State Parks for 15 years and was an Interpretive Specialist. He will be stationed at Norris Dam
 State Park and will attend Ranger Enforcement School in October. Two more Park Rangers (one a
 manager) will be on board for the CTSP the first of the year.
- Arleen stated that the Trail Training Workshop for 2001 would be expanded to two days. It will take
 place February 23-25, with the location to be announced. Sessions will be offered for beginning,
 intermediate, and advanced trail builders. The workshop will offer complete CPR/First Aid
 certification for Trail Leaders, a WagonMaster training session for BreakAway, and an apprenticeship
 for footbridge construction. The workshop will be open to the public due to the demand. Fees will be
 initiated to cover costs.

V. Development

Smoky Mountain Segment —
Rob Weber stated that the Cumberland Mountain Segment and the Smoky Mountain Segment would
connect via the I-75 corridor, approximately 3 miles in length. We expect approval from TDOT next
month to proceed with this connection.

Barry Spearman and Jim Johnson have been analyzing the bridging project over Cove Creek. Two quotes from bridging companies were obtained to construct a truss-type bridge with a span of 85 feet. Due to the flood possibility, this span is optimal. Due to the span, a 5-foot width will be required. Cranes will be required to place the bridge after it is assembled along the road. Estimated cost is \$75,000. To allow the current RTP grant to cover the construction of both the Cove Creek and Smoky Creek bridges, Barry was asked to lower the project costs. Barry will work with the Trail Stewards to obtain contacts that may assist with cost cutting.

VI. Pathways for People...People for Nature Capital Campaign

- Rob stated that six district campaigns will be conducted simultaneously in the cities of Chattanooga, Knoxville, Nashville, Oak Ridge, Crossville, and LaFollette. There will be a campaign chair for each district with a central Campaign Steering Committee to oversee everything. Rob distributed an acquisition document for the CTSP, and related costs, justifying the need for \$2.4 million in acquisition funds. By using Waters, Pelton, Ostroff & Associates (WPO), we will be paying for professional fundraising services, as well as Bill Brown's affluence and influence in the communities. We feel that this is necessary for the successful completion of this campaign.
- WPO Contract Review:
 - > The established campaign goal will be set at \$3 million, to include costs.
 - WPO will hire a full-time campaign assistant.

- ➤ WPO's fees will be around 8% with incentives for more money earned.
- ➤ At issue with the contract was "Gifts of Non-salable Lands". It was decided that the "review clause" should remain in the contract to allow the Council to have the final decision on the acceptance of non-salable lands. This issue will be addressed further in a meeting between Bill Brown of WPO and Linda Hixon of NCCC.
- The contract with WPO shall run for 20 months commencing on August 7, 2000.

VII. Corridor Acquisition

Funding –

Rob stated that \$650,000 of LWCF funds from the State has been designated toward the acquisition and development of the CTSP.

Black Mountain –

The Tennessee Parks and Greenways Foundation will hold a Black Mountain Fundraiser kickoff on August 25th at Cumberland Mountain State Park. The Council agreed to turn over our Black Mountain Acquisition Fund to TPGF if deemed appropriate at this time.

Bowater Southern Watersheds –

The watersheds are located between North Chickamauga and Laurel Snow. Rob reviewed map handouts of the Rock Creek, Possum Creek, and Soddy Creek watersheds. Rock Creek was considered to be the best due to access and water quality, as well as offering recreational opportunities. It is also protected from the impacts of mining under a "not suitable for mining" petition. Possum Creek has water quality issues due to mining. Parking may also be an issue, but there is a right-of-way into the gorge and it offers recreational opportunities. Soddy Creek is the weakest of the three due to a strip mine with open portals, which creates liability as well as water quality issues. The Office of Surface Mining will be out in two weeks to test the water quality. Additional information has been requested of Bowater, to include access issues. We are prepared to complete an appraisal of targeted Bowater watersheds in the immediate future.

Bowater is selling land under the bluff line, not on the bluff line. The Council raised the question as to whether our trying to purchase lands on the bluff lines was important due to our budget restraints. Would we be able to garner permission from Bowater to access bluff overlooks? A suggestion was made to buy the gorge with some bluff line, i.e. Rock Creek, or possibly get a trail easement with Bowater for future conservation work. Bowater, however, is not interested in trail easements at this time. Discussion then pursued on us keeping our focus simply on the corridor, within the watersheds, within budget.

The Conservation Fund, Rex Boner, has agreed to partner and provide the level of assistance required to complete the project. They will be involved with land negotiations.

Cumberland Mountain Segment –

An appraisal has been completed on the Phase II 28-mile stretch of J.M. Huber land. We will make an offer, and hopefully, close in August. A trail survey will begin this fall. Phase III is the last stretch on this segment and will begin once the J.M. Huber work is complete. It consists of 9 miles and 70 private landowners.

Frozen Head Segment –

The first landowner meeting was held with 28 landowners from Nemo Bridge to Bird Mountain. The Bird Mountain acquisition, planned for Frozen Head State Park, is being utilized as a match against the LWCF funds.

North Chickamauga –

Linda Hixon reviewed a map of the area. Conservation easements will need to be made with the Pattons to cross their lands to link the CT.

VIII. Programs

 Arleen handed out a letter from a student at Michigan State University who attended our spring BreakAway program. We received 23 other letters, very similar in nature, attesting to the impact our BA program has on students' lives. The demand from schools to attend our BA program is

- unbelievable. We starting receiving calls in June from schools wanting to attend our BA next year. We are sending out applications, and already have 3 schools confirmed.
- The AmeriCorp NCCC team outing in May went very well. An additional 4 miles of trail was built in 6
 weeks on the Smoky Mtn. Segment. We are hoping to get another team this fall for six weeks.
- A BackCountry Outings Committee met to design the new programs for 2001 (see handout). The
 backcountry outings will be expanded in 2001 using volunteer leadership to meet the additional trail
 building demands on the CT. Arleen discussed volunteer leadership certification, roles and
 responsibilities, compensation, scheduling, and funding strategies.
- Arleen reviewed the Program Overview handout outlining program outings scheduled this fall and in the spring of 2001.

IX. New Business

Sam Powell stated that the Sequatchie Valley Rail-Trail resolution has been signed by the Tennessee
Conservation Committee (TCC) garnering support for the creation of the Sequatchie Valley Rail-Trail.
It will be up to the Tennessee Rails-Trails Advisory Council (TRAC) to put momentum behind this
resolution to make it effective.

The meeting was adjourned at 12:30 p.m.

Re: Kentucky Trails Association formation.

A petition to ask TTA's Board to make a concerted effort to establish the Kentucky Trails Association (KTA) over the next 12 months for the following reasons:

- a) Kentucky has no statewide trail organization representing the hiker.
- b) TTA is the principal agency in the SE capable of establishing KTA and has a proven record of accomplishment and reputation for establishing TTA Chapters within TN.
- c) HA, serving as a sister organization to TTA, would offer a wide range of additional recreational options to our Tennessee members.

The following KTA issues relate directly to the creation of the WAA (Western Appalachian Alternative, 2nd AT):

- d) The Pine Mountain Trail Association is failing due to the lack of a statewide support group. The PMTA is the northern connector to the CTSP at CGNHP (Cumberland Gap) and a critical 100-mile link in the WAA structure.
- e) The River and Trails Conservation Assistance (RTCA), which is a National Park Service (NPS) community assistance organization, has chosen two groups to sponsor in the SE from their new Chattanooga office beginning October 1, CTC and PMTA. This assistance will be provided by Alison Brayton, who is currently leaving her position at TDEC, Recreational Planning Division, to work for RTCA. Alison is dynamic and committed to trails and greenways and has played a lead role at TDEC for the CTSP. Alison is capable of firing up the PMTA but needs our assistance in establishing a support organization, KTA.
- f) We have pushed the WAA issue to the forefront in SE with a meeting taking place this fall with regional partnering trail organizations to establish the groundwork for this program. The WAA will require a multi-organizational effort and TTA's role in establishing KTA is paramount to the success of this project.

My recommendation is that TTA's Board except this challenge by establishing an initial Chapter in Bowling Green (pre-existing TTA members) and then following through with chapters in the major metropolitan cities.
