Call to Order/Welcome

Meeting called to order at 12:56 PM by President, Rosemary Marshall.

II. 4<sup>th</sup> Quarter Meeting Minutes

Don Dresser **moved** to approve. LouAnn Partington moved to approve as amended with the following addition:

Vendors at the Annual Meeting.

Motion: Move that we have no outside vendors at the annual meeting. Seconded: Ray Garrett. After some discussion, the motion passed with 3 nay votes.

February 2, 2008 First Quarter Board Meeting: amendment to the minutes of the 2007 Fourth Quarter Minutes. Motion regarding vendors at the Annual meeting was tabled.

Don Dresser revised his **motion** to approve as amended. Motion was seconded and motion passed with a unanimous vote.

- TN Rails to Trails Advisory Council (TRAC) still have an open position for a representative to serve on the TTA Board.
  - Fount Bertram says that there is some activity in East Tennessee area
  - Currently a rail line might be abandoned in the Oneida area.
  - TRAC still an associate organization of TTA.
  - Bob Richards State Trails Coordinator.
    - o Recently met with governing to discuss Clarksville railroad.
    - Johnson City is buying right-of-way from Johnson City to Elizabethton to convert to a rail-to-trail.
    - Monteagle has approximately \$500,000 grant for a rail to trail along part of the Mountain Goat Rail Line.

**Motion** to appoint Bob Richards as TRAC representative to TTA was made by Nora Beck. Motion seconded by Fount Bertram. Motion passed with a unanimous vote.

### VIII. Annual Meeting Report for 2007 - Carolyn Miller

- o Around 201 pre-registered, but ended up with around 211 members in attendance.
- o Thanks to all the members who attended.

- Thanks for all the miscellaneous donations, as well as the donations for the live auction and silent auction.
- A total of \$6420.30 was raised and donated to the Cumberland Trail Conference for the 2008 breakaway and trail building projects.

#### IX. Old Business

- a. Betty Porter letter Rosemary Marshall read a thank you letter written by Betty Porter in regards to her being one of the crew of three that were presented the 2007 TTA Award.
- b. PSA for TTA (15 minutes) Debbi Hicks
  - o 30 second PSA was shown.
  - Materials cost \$247 for the BETA tapes to be reimbursed by TTA. Actual value around \$1600.
  - o Packet of information how to contact television stations.
    - List of stations.
    - Sample e-mail letter to contact a television contact either in programming or traffic.
    - You take the tape to the station and they will make a copy of your tape. DO NOT give them the tape.
    - Need contact info in order to write a "Thank You Letter".
    - Can also go to your local cable company ask for the "traffic" person.
- c. 2008 Evan Means Small Grants Committee Report LouAnn Partington.
  - 2007 grant reports all follow up reports have been received except for the group in Memphis.
  - Any volunteer based non-profit agency can get a grant to assist with trail building project.
  - o 4 submissions for 2008
    - 1. CTC \$600: Support Spring Trail building Project April June
    - 2. Ohio State University Group to work at Cumberland Gap State Historic Park \$ 300
    - 3. Friends of Beaman Park building bridges at Beaman Park recommend \$600.
    - 4. Watershed Association at Tellico Reservoir. Benches along the trail \$637.

**Motion** by Libby Francis to fund all four projects for the amounts specified. Motion seconded by Garnett Rush. Motion passed with a unanimous vote.

d. Vendors at the Annual Meeting - LouAnn Partington

Motion was previously tabled at the 4th Quarter Board Meeting.

Therefore, the motion is still on the floor.

Discussion:

LouAnn sent e-mail survey to all the chapter chairs:

One reply was absolutely not and two were in favor.

The other responses wanted information only tables with no items to be sold.

Think that vendors could advertise TTA through their website.

Difference between a vendor and a sponsor.

#### Alternatives:

- 1. No vendors at all.
- 2. Information table no vendor in attendance.
- 3. Vendor demonstration tables.
- 4. Vendor demonstration tables and allowing sales.

If demos, when would they have time to demonstrate their wares? Bob Richards – says we should seek "sponsors" versus vendors.

**Motion** tabled from the 4<sup>th</sup> Quarter meeting, "**Motion:** Move that we have no outside vendors at the annual meeting". The motion did not pass as there were 4 yea votes and 8 nay votes.

**Motion** by Don Dresser to allow for the 2008 annual meeting to have an information table with details to be decided by the local chapter with the Board to subsequently review whether providing the information was disruptive to the meeting and to review the policy. Seconded by Tom Bentley. Discussion: this will put a burden on the local chapter. Others said that no harder to ask for information than to ask for a donation of an item for the auction or a donation for the annual meeting.

Motion passed with 14 yea votes and 1 nay vote.

#### X. New Business

- a. Alliance for the Cumberlands Fount Bertram
  - Purpose is to protect the Cumberland Mountains, including the land and water.
  - No Dues and no fees.
  - TTA has been asked to join the Alliance all we have to do is fill out an application for membership.
  - Question: Do we need to appoint a representative? Fount Bertram offered to represent TTA.
  - o They publish a newsletter that would allow for publicity for TTA.
  - Motion made by Ray Garrett that TTA join the Alliance for the Cumberlands.
    Motion was seconded by JR Tate. Motion passed with a unanimous vote.
  - Motion by Garnett Rush to accept Fount Bertram as the TTA representative to the Alliance for the Cumberlands. Motion was seconded by LouAnn Partington. Motion passed with a unanimous vote.
- b. Southeast Foot Trail Coalition (SEFTC) Leadership Council Next meeting: May 3 in Chattanooga.

As of June 30, 2008, American Hiking Society will discontinue all financial support for the SEFTC. There are 37 organizations making up the SEFTC. **Motion** by Fount Bertram to contribute up to \$300 for TTA to become a member organization of SEFTC. Motion seconded by J. R. Tate. Motion passed with a unanimous vote.

**Motion** by Fount Bertram to request \$100 to pay for food at the SEFTC Leadership Council meeting. Motion seconded by JR Tate. Motion passed.

- c. Discussion of Hikers with Social Issues
  - a. For people who cannot get along on hikes or cause a disruption due to their personal interactions.
  - b. Rosemary will write a letter to each of the parties to state that they need to handle their personal matters in a private manner.
- XI. Presentation by Daniel Reese, Chairman SAGA (Southern Appalachian Greenways Alliance)
  - Organization started about 10 years ago.
  - Represent hikers and bicyclists.
  - o Goal to interconnect trails in Tennessee and Virginia.
  - o Present at the meeting in order to partnership with TTA.
  - o Currently, have a Rail-to-Trail project in Johnson City.
  - o Blue-ways for kayakers.
  - Wants to work with ATV and ORV groups to use public lands appropriately.
  - Appalachian Resource and Development Council is the parent organization.
    It has a 501 C3 status.
  - o Affiliation: they would like to have a representative on our board.
  - o Currently developing a website.
  - October 24 Southern Appalachian and Greenways Alliance meeting in Abingdon, VA.
  - No action was taken regarding a formal relationship between TTA and SAGA.

  - o Cumberland Trail Award Gary and Doris Ruetenik
- a. Update on both book deals.
  - Russ Manning is interested in writing a trail guide to the open sections of the Cumberland Trail.
  - Coffee Table Book financed by Justin Wilson.

Have a contract with Bill Campbell for the photography with the text to be written by David Brill.

- b. Update on Rock Mining Ray Garrett.
  - Appeal of the judge's decision is in progress.
  - CTC is supporting amicus curiae brief (Friend of the Court)
  - Two bills have been introduced in this legislative session to include surface rock in the mining laws. Info about the bills is on the CTC website.
- c. CPA Opening for CTC Audit.
  - Don Dresser is currently interviewing two firms in order to find a replacement CPA for the CTC.
