Big South Fork Chapter (INACTIVE)

Clarksville Chapter – J.R. Tate (Absent)

We were part of the Austin Peay State University "Wellness Expo" on February 26. Our TTA display generated lots of good comments and interest. We will participate in the upcoming Clarksville Rivers and Spires Festival April 25th and 26. Other than that, it's business as usual—Saturday hikes and monthly programs. We are still pushing membership renewals and new members.

Columbia/Franklin Chapter – Marvin Caine

We have had three very good monthly meetings this quarter. In February, Tommy Haskins presented a program on the geology of Tennessee. In March, Lou Laretta and Ellen Clark gave a presentation on their 2009 trip to the Patagonia Region of South America. At our April meeting, Betty Smallwood presented a program on Armenia and its culture where she served as a Peace Corp volunteer from 2007-9. We continue to have two hikes a month. Our most popular one was our hike on property of the Swan Trust in March. We also were treated to a tour of "The Farm" near Summertown, TN. Around eighteen attended this event. Another noteworthy hike was on the Twin Arches Trail in the Big South Fork. A small bear cub was encountered along the trail. No mamma bear was seen, however. Our chapter also participated in the wildflower hike at Stillhouse Hollow Falls in April sponsored by the Tennessee State Natural

Areas Division. Three from our chapter helped the Harpeth Watershed Association to plant trees along the Harpeth River in Bellevue in March. Four new members were added during the quarter.

Highland Rim Chapter – Linda Hudson (Absent)

We have been very active with hikes every weekend. We continue to add new members. Highland Rim is alive and doing well.

Jackson Chapter – Vicki Moeller (Absent)

A few of our hikes were cancelled due to the weather. Places we hiked were Tishomingo State Park; Shakerag Hollow in Sewanee; Fiery Gizzard; Cane Creek; Pinson Mounds; Big Hill Pond. Helped with trail work at Natchez Trace SP.

Memphis Chapter – Charlie Bright

Our most important activity has been the debris clearing at Meeman-Shelby Forest. There have been several major storms this year. The Memphis Chapter has donated about 150 hours of volunteer time over about two months. Wayne Simpson and Pat Mazzeo were the leaders and several other members and non-members have done a lot to make the trails usable. We had eleven hikes this quarter and averaged about 12 members per hike. All but one was in West Tennessee. We also hiked several trails near the Buffalo River in the vicinity of Jasper, Arkansas. We had six new members bringing our membership to 57.

Nashville Chapter – Doug Burroughs

The Nashville Chapter of TTA continues to hold our monthly meetings at the Brentwood REI. January was our annual hike and program planning meeting. February's meeting guest was Sue Biggers who presented pictures and souvenirs from her trip with Garnett Rush to Scandinavia. They went to Norway, Denmark, and Sweden. In March, Rick Lausten came up from Franklin to show us photos and talk about his trips to Isle Royal National Park, which included an end-to-end backpack, and to the Apostle Islands for kayaking. Nashville had a total of seven hikes from January through March 2014; they were: Road walking at Warner Park, Johnsonville Historic State Park (which will be on the Annual Meeting schedule), 12 miles on the trails at Warner Park, Montgomery Bell State Park, Laurel-Snow Falls, Shelby Bottoms, and the Collins Gulf Loop. One hike (to Bells Bend Park in Nashville) was cancelled due to rain. Several meetings to work on the 2014 TTA Annual Meeting were also held during this quarter. Plateau Chapter - Cheryl Heckler

Our membership is 66. We schedule weekly Wednesday hikes and at least two Saturday hikes per month. We did a joint hike with Upper Cumberland Chapter in February. Our annual overnight trip is scheduled for April 26 & 27 which is a waterfall extravaganza in NE Georgia Mountains. This year we are alternating our monthly chapter meetings with a program one month and a dinner meeting the next month. Soddy-Daisy and Plateau Chapter have decided to use the 2013 TTA Annual meeting proceeds to improve a trail. We are exploring ideas for that. We are planning to meet with Cumberland Mountain State Park to talk about a footbridge on Pioneer Loop as a possibility. Our chapter has met with the Cumberland Trail rangers and is starting the repair project of the steps on the Black Mountain for the Evans Means Grant. We had a trail maintenance day clearing out adopted Black Mt Loop trail on March 31 and are planning one to cut back the briars on Brady Mt. We are supporting a group called Crossville Trails who are trying to build more trails in Crossville. On April 19, some members helped work on creating a new trail at Meadow Lake.

Soddy Daisy Chapter - Ed & Donna Pyers (Co-Chairs)

Chapter membership at 35 with 2 new members. During the second quarter the chapter conducted over 20 hikes (Sat. & Tues.) This quarter several members have worked with the CTC as volunteer workers on various Cumberland trails. Several members volunteered for the Spring Break-away. Five members attended the 23rd Wilderness Wildlife Week at Pigeon Forge (Jan. 12th-19th). Chapter quarter meeting was held April 1.

Sumner Trails Chapter - Jane Hamm and Gayle Livingston (Co-Chairs; Absent)

Our February chapter meeting was held at Barefoot Charlie's in Hendersonville where we enjoyed dinner together and Trivia Night. We had a huge member turnout since we always have fun playing trivia and competing with other teams. Although we didn't win any rounds this year, we had a great evening of camaraderie and high expectations of improving our scores next February! In March, Rick Lausten from the Columbia-Franklin chapter presented a slide show of his 4-day, 3-night kayak trip to the Apostle Islands in Wisconsin. We enjoyed hearing about his journey and

viewing many of the incredibly beautiful caves which lie along the shoreline of Lake Superior. Rick also showed us pictures of the caves this winter when they became completely frozen, giving the appearance of beautiful ice castles. Hendersonville native and Appalachian Trail thru-hiker, Drew Beeler, gave a presentation at our April chapter meeting about his six month hike to complete the AT. Drew took a year to prepare for the hike after graduating from MTSU in 2012. He covered everything from gear needed to the community of hikers and trail angels that come together to make up the entire AT experience. He also shared stories of hardships along the way and what it took to overcome them. Our membership is at approximately 37 individual and family units. Sumner Trails offers two to three hikes per month, with an occasional mid-week hike. We have enjoyed four great hikes in April, a reflection of beautiful weather! Our chapter is also having monthly meetings with the Nashville chapter in preparation for the Annual Meeting in Oct.

Upper Cumberland Chapter – Louise Miniard

The Upper Cumberland Chapter has been hiking every Saturday. We had two meetings at Outdoor Experience to help promote hiking. We had several people come to the meeting. At one meeting, Outdoor Experience showed the latest in new equipment for hiking.

Reports by Associate Organizations:

Cumberland Trail Conference – Frank Jamison

Breakaway was successful, lots of new trail built, recent inventory in good shape. He is hoping to report more frequently in the future, on a project to project basis.

National Trails Day – Bob Richards

June 7th Bob Richards circulated copies of American Hiking Society's webpage with instructions for registering. Reported that TN was 5th in the nation in 2013 for participation with 104 events. He suggested each chapter sponsor one event and get some ideas by looking at the 2013 final report.

Old Business

Website Committee – Millette Jones

Millette says it's way beyond her abilities and that we should approach the people that worked on the CTC website for help. That would be Kelly Stewart and Russ Manning.

Annual Meeting Review Committee – Carolyn Miller

Reported that things under discussion are: fund raising options, registration fee, entertaining, using colleges.

Annual Meeting 2014 Update - Doug Burroughs

Report circulated < ATTACHED >. Buffet dinners will be \$20.00, obtained a hospitality room, option on registration form for donations (Evan Means, and for the website infrastructure). He made a request for information on how to obtain alcohol donations. Charlie Bright said a relative of his will donate a keg (as he did last year), Cheryl Heckler said they (Plateau) approached local wineries, and that Soddy Daisy donated some. Also Marvin Caine said that Bobby Hardeman was able to get a donation of bottled beer.

New Business

Evan Means Grant Fund - Bob Richards

Report circulated < ATTACHED >. 2013 Grants dispersed just after Feb 2014 are as follows: \$1,000 for CTC, \$600.00 for Edgar Evins, \$586.80** was requested by Upland Village for creating and maintaining trail in and around their CCRC in Pleasant Hill. It would be open to the community and maintained by residents and scouts. It involves about 5 miles of trail and they will be adding handicap trail. **Bob amended the original list of tool requests and the dollar amount requested was also amended to \$585.75. Bob recommended to the board to fund them with the rounded-up number of \$600.00. Levonn Hubbard moved for approval and Don Dresser seconded. The motion was carried.

Levonn Hubbard suggested that all tools be returned to TTA when no longer needed and that we should maintain an inventory. This should be a caveat to all Evan Means grants and part of the application process. Rosemary Marshall questioned the time limitation on the grant requests. People who apply on time get first cut but people can apply anytime. Levonn also wants accountability from grant recipients, and says that we should not give grants to recipients that don't supply accountability.

TTA Committees: appointments by Carolyn

Made up of the 2 past presidents (Millette Jones and Don Dresser), also Cheryl Heckler. Carolyn would like to see more and will ask Cheryl for suggestions.

Chaired by Treasurer (Kathy Woods), the Board will appoint 2 others. Carolyn suggested Don Dresser and Frank Jamison. The motion was made by Levonn Hubbard and seconded by Millette Jones. Motion carried.

Annual Meeting Committee

Chaired by Carolyn Miller.

Cumberland Trail Committee

Carolyn Miller, Levonn Hubbard and Frank Jamison have identified several prospective members to be added to this committee. Carolyn will update us regarding the outcome of this committee's members. Prospective members: J.R. Tate, Larry Hill, Gary Rutnick, Linda Hickson, Judy Varner, Gary Darnell.

TDEC and State Parks want TTA to be lead organization for CTC. Will no longer work with CTC, so if TTA wants to be involved in the Cumberland Trail we must take over the responsibilities of the CTC. The state wants to finish the trail within 5 years. We have over \$700,000.00 in lifetime memberships and other donations earmarked for the CT. We have a responsibility to our donors.

A motion was presented by Millette Jones:

I move that Tennessee Trails Association create a new committee, to be called the Committee for the Cumberland Trail, for the purpose of working with the State of Tennessee, its Departments and other interested organizations to complete the Cumberland Trail;

Further moved, that the President of TTA shall appoint such members to the committee as she determines appropriate to carry out this mission, and shall also have the authority to remove or replace such members as she deems appropriate;

Further moved, that the existing TTA associate organization Cumberland Trail Conference is hereby dissolved, that all money, financial assets, records and property in the possession of CTC are hereby transferred as of this date and time to TTA and assigned for use by the new Committee for the Cumberland Trail; that the new committee shall inventory the property it receives from CTC; and that the Treasurer shall take such steps as are necessary to be certain that the money and other financial assets are secured and available for use by the new committee;

Further moved, that the new Committee for the Cumberland Trail may, on behalf of TTA, hire the existing employee of Cumberland Trail Conference commencing as of this date on such terms as it determines appropriate;

Further moved, that the new Committee for the Cumberland Trail may, in coordination with the Treasurer of TTA, manage the bank and other accounts previously employed by Cumberland Trail Conference and from those accounts pay such amounts as it determines prudent and necessary for the building of the Cumberland Trail; and that the new Committee for the Cumberland Trail shall in advance of the next regularly scheduled meeting of this board submit a proposed committee budget for the remainder of this calendar year;

Further moved, that the President of TTA shall promptly advise the State of Tennessee, the Cumberland Trail Conference and its directors, members and employees of the foregoing actions.

The motion was seconded by Louise Miniard; and, the motion unanimously carried.

Discussion was had about adding and deleting signatories from bank accounts and it was put on the agenda for the Committee (CCT). Don Dresser will draft a motion to change the names on the accounts and send it to Carolyn, and to Diane. A motion was made by Don Dresser and seconded by Frank Jamison and carried. The motion was to change the names on the account.

Lastly, the Board will mail a letter to chapter chairs for them to forward along to their members regarding these changes.
