Cumberland Trails Conference - Rob Weber

Rob presented CTC's Dec 6, 2014 Board Meeting minutes and CTC's Jan 15, 2015 CTC/TTA Reorganization Plan (with plans, timeline and framework). < Dec 6 meeting minutes and Jan 15 plan are attached > CTC elected new board members recently; Jan 24, CTC is seeking reorganization and at the same time filing of a separate 501c3 non-profit membership organization status. Of course, CTC would continue to retain some sort of relationship with TTA. Don Dresser reminded the board that a vote will be required by TTA for the CTC to commence the 501c3 application process. Allowing CTC to pursue a 501c3 designation would create two legal entities; one TTA; the other CTC; thus making both entities more efficient.

Motion: Don Dresser made the motion that TTA authorizes Rob Weber and Frank Jamison to create a new Tennessee non-profit corporation, and to seek Section 501(c) status for that corporation; and that TTA will cooperate with Rob Weber and Frank Jamison and the new corporation to spin off assets of the Cumberland Trail Conference to that new corporation on terms and conditions to which TTA and the new corporation mutually agree; and that, as needed and requested by the new corporation for the payment of start-up expenses, TTA authorizes a loan of as much as \$5,000 to that corporation, to be repaid at the time of the spin-off.

Motion 2nd by Bruce Whitehead.

<u>Further discussion</u>: There will be a need for a memorandum of understanding (MOU) to be presented to the membership, after approval by the board which would specify what needs to happen as far as working together and the transfer of funds. Everyone was asked to read up on the by-laws.

Motion carried unanimously.
