Brief welcome and introduction of those present.

Approval of 4th Qtr 2015 General Membership & Board Meeting Minutes – David/Cindy Bowling (for Diane Manas)

Motion to approve made by Garnett Rush, seconded by Bruce Whitehead, Motion carried.)

Budget Approval for 2016 - Kathy Woods

The Treasurer's Report was circulated by email prior to meeting for review. <attached>

Kathy Woods explained an increase in cash revenue for 2015 due to \$64,200 donation from Charles Klabunde Trust. Kathy also stated that proceeds from 2015 Annual Meeting had not been received before the end of the year. The proposed 2016 budget was then discussed at length. Bob Richards and Naullain Kendrick described applications for Evans Means grants submitted from Friends of South Cumberland and Cumberland Trail Conference.

Friends of South Cumberland requested \$1000 on their Evan Means Grant application. attached Naullain Kendrick explained that the amount requested would cover only part of the total cost of the equipment described in the request for trail construction/improvement which consisted of a hoist for moving heavy boulders and the corresponding cables, ropes, and fasteners. Upon discussion, there was general agreement to increase to amount in order to cover the total cost. Motion was made by Kathy Woods to approve \$2,000; seconded by Bruce Whitehead. Motion carried.

Cumberland Trails Conference (CTC), Insufficient information was on the CTC's Evan Means Grant application. <attached> Motion by Jim Poteet to defer the CTC application until they submitted the necessary information; seconded by Carolyn Miller. Motion carried.

A proposal for development of the TTA website had been submitted from Sitemason, Inc. of Nashville <attached>. After discussion, it was recommended that a website committee be created to determine website criteria, which would ultimately be included in proposals being requested from multiple vendors. Those volunteering to be on the committee were Charlie Bright and Jim Poteet.

During the budget discussion, increases in certain line items were recommended, including approving the request from Friends of South Cumberland. Revenue and expenses related to membership were discussed. There appears to be a need to streamline the process currently used when renewal/new member checks are received. Kathy Woods will review the current process and make recommendations for improvement. It was suggested that members be encouraged to request the newsletter in electronic format, which would result in postage savings.



BRIEF description of your organization and history:

The Friends of South Cumberland (FSC) is a group of volunteer citizens dedicated to supporting the South Cumberland State Park, Tennessee's largest state wilderness park. Founded in 1993 as a non-profit membership corporation, FSC's mission is to support South Cumberland State Park, preserve and protect it, and to serve as a mechanism for involvement. Our major activity has been to purchase land. When FSC was formed, the park covered 16,000 acres. Today it covers over 26,000. We sponsor a range of educational activities, including:

- Trails & Trilliums, an annual festival providing a great forum for environmental programs, workshops and hikes (13th year)
- · A chapter of the TN Naturalist Program (now in its fourth year)
- Annual themed challenge to encourage more to travel to SC to hike (now in third year)
- Every Child in the Park annual field trips and programs for students in Grundy County schools (for over ten years)

We provide support to the rangers in money and volunteer power. We recently launched a "Back the Rangers" program that provides volunteers to helping staff the Visitors Center, and we are currently renovating the displays and exhibits in the Visitors Center.

Friends of South Cumberland Fiery Gizzard Trail Project



Project Description

The Friends of South Cumberland (FSC) seek funds on behalf of South Cumberland State Park to assist in tools needed for the trail re-route of the Fiery Gizzard Trail, a 12.5-mile bluff trail that connects Fiery Gizzard/Grundy Forest with Foster Falls, two of the best know parks of the ten that make up the South Cumberland. In August 2015 Interim Park Manager George Shinn received word that the new owner of Raven Point Farm, which the trail has crossed for decades. asked for the removal of the park trail from his property by Dec. 1. Unfortunately, another property owner has followed suit, and has given Dec. 1, 2016 as the date to re-route the portion of the trail off of his property. Though this information has not been made public, it underscores the need for the rangers to have the tools needed for trail building, now and in the future.

Because this trail has garnered national attention for the South Cumberland and is beloved by thousands of hikers, finding a way to re-route it as quickly as possible was a priority. Backpacker Magazine named the Fiery Gizzard Trail among the top 25 hiking trails in the U.S. and in 2014 ranked it 6th on the list of Best Fall Foliage Hikes in the nation.

To skirt the private land, the new trail will plunge to the bottom of the gorge and back up to the rim, with an 800-foot change in elevation each way, and will cross the Fiery Gizzard Creek twice. Essentially the trail will be two long staircases, one going down and one going up. With the direction of the rangers and a massive volunteer effort that began in August, 80% of the trail has been completed to date. Because of the success of the fall effort, the trail did not have to be closed on Dec. 1 as had been feared. The re-route was far enough along by that date to consider the new trail "open." However, neither bridge has been built and much of the trail is passable but in need of further work. The time pressure now is to get the bridges constructed before the spring rains. If this work is not completed by March, the trail will have to close to hikers during the high water season, which is a high-use time for both hikers and wildflower enthusiasts

We are asking the TTA to consider providing funds for an Uplift Kit Hoist System in order to convey materials and tools into the gorge. Jason Reynolds, the ranger in charge of the re-route project, named this as his First Priority immediate need. Currently the rangers are borrowing a hoist system from Cumberland Trail, but that is a short-term loan. The hoist will be essential in the building of the two bridges, and the rangers are confident they will have future uses for this piece of equipment once the Fiery Gizzard Trail is complete.

The model Jason hopes to purchase is a CMI Uplift Kit Hoist System, which is similar to the one now on loan from Cumberland Trail. (Kit can be viewed at this website):

The hoist kit is by far the most expensive component of the system, and will work without any cable for short distances. The cable and cable trolleys and pulleys will allow the entire system to move over large distances.

Friends of South Cumberland Fiery Gizzard Trail Project

Benefits to Tennesseans

Tennesseans will benefit from this new trail directly if they are among the hundreds who use the trail annually for backpacking and camping. Indirectly, all residents benefit economically when tourism in TN is strong. Because of the national reputation of the Fiery Gizzard Trail, creating an alternate route rather than shutting down the trail enhances the state's reputation as a destination site for hikers from across America. This trail is credited with drawing visitors to South Cumberland and enhancing tourism and the local economy in Grundy County, one of Tennessee's most impoverished areas.

When the trail is completed, we will celebrate the pugnacity and spirit of our rangers and volunteers. We Up, which is being used to coordinate our volunteers, swelled from 200 to over 460 members in the months following our publicity about the trail. This will be a great opportunity to draw attention to the South Cumberland as a park worth visiting. In the end, we will have a completed trail, though one more difficult to hike than the original one along the canyon rim. We stand to gain the most in PR around this effort. It is also a possibility that through our publicity we will inspire a philanthropist to purchase the Raven have had an amazing outpouring of support from TTA as well as others in the tri-state area. The FSC Meet Point Farm tract (now for sale) and put easements on it. In that case, we would regain the bluff trail and have, in addition, an amazing new trail that takes hikers deep into the gorge through wild and untouched areas.

Will other groups be involved in this project with you? Please list their involvement and actions: List any other funding sources and amounts to be used to complete this project:

- The need for funding for the trail is pressing. Interim Park Manager George Shinn is now taking money from his park operating budget for trail re-route expenses. Because he was unaware of the threat to the trail when he submitted his budget, he has no money allocated to this project in his June 2015 - July 2016 budget. Ranger Shinn has asked the FSC to help identify sources of income to assist.
- At this point TDEC has not allocated any funds for the trail project or indicated plans to do
- For 22 years the FSC has supported the park financially. Because we recently purchased three significant tracts of land, our coffers are depleted. We are planning to launch a significant fundraising effort in 2016. Until the state buys back some of the tracts now being held by the FSC, we have limited resources with which to support the trail re-route. Instead, we are working to find sources of funding for the project.
- In October the FSC submitted a grant proposal to the Lyndhurst Foundation of Chattanooga detailing the need for \$53,885 in materials and tools for the trail project. In Nov. Lyndhurst awarded the FSC \$25,000 towards these costs. This amount essentially covers the lumber and pallets of sandstone needed to build the rock staircases, but does not cover the significant costs of the two bridges, a cable hoist system, or a four-wheel vehicle with a loadbed.
- · An informal ask was submitted to REI in Nashville but was not approved.

South Cumberland State Park Partnership Letter

Dear Tennessee Trails Association (TTA),

As the 'interim' park manager at the South Cumberland State Park, I am offering this letter to explain the wonderful partnership that our park has with the Friends of South Cumberland.

The Friends is a 501C3 support group established in the late 1990's and this group is dedicated to supporting activities that promote and protect South Cumberland Recreation Area. The group has a tremendous board of talented people that conduct regular board meetings to plan and conduct business. The Friends also have many active committees that focus on specific activities for our visitors and this keeps the group's energy high and efficient.

The Friend's activities and efforts have been too numerous to provide a complete list, however some of the highlights are provided below:

- Raised over \$600,000 in donations and \$2.5 million in grants to complete a "Saving Great Spaces" fund raiser to purchase critical holdings of land adjacent to the park boundary to protect the natural and cultural features of the park. The Friend's acquisition effort allowed a partnership with the state of Tennessee resulting in the addition of over 8,500 acres to South Cumberland.
- Purchased a new patrol truck for Stone Door so that the ranger did not have to borrow the maintenance truck to perform his duties. The state was unable to fund this vehicle that is required by policy. As a result of this donation, many visitors have been provided emergency medical, law enforcement and rescue services that may not have otherwise been available.
- Partnered with the Monteagle Assembly to build a ranger residence at Grundy
 Forest. This park trailhead area experienced over 30 vehicle burglaries over several
 months. Once the residence was completed and a ranger was moved on site, the
 car burglaries stopped.
- Paid to have a contractor build a picnic shelter at the South Cumberland visitor center. The state was unable to fund the shelter. Almost every day, visitors picnic, meet, have family reunions, etc. under this picnic shelter. Without this facility many of these activities would not have been enjoyed on the park.
- The Friends partner with the state of Tennessee, Tennessee Parks and Greenways Foundation, South Cumberland Wilderness Society, Savage Gulf Preservation League, The Land Trust For Tennessee, The Conservation Fund, Lyndhurst and Benwood Foundations and many other groups to leverage their efforts and share ideas.
- Purchased two rescue/patrol dogs to support law enforcement and help protect visitors.

- Provide annual outreach to local school children in grades 3-5 as well as adult
 environmental education providing environmental programs and training.
- Provided six canoes, canoe trailer and paddle gear, rock climbing ropes, harnesses, helmets and rock climbing gear so that park staff can offer special programs to benefit park visitors.
- Conducts and supervises numerous work days to clean and repair trails, build bridges and improve park and trail signage.
- Conducts an annual "Cumberland Wild"/ "Trails and Trilliums" event to raise awareness of the park and promote opportunities for recreation and education on the park.
- Supports annual community programs including an Easter Egg Hunt and a Fishing Rodeo on park lands that are attended by hundreds of local children and families.
- Promotes the park in print and TV media, sends monthly emails about park events, maintains a website on park activities that has over 1,000 subscribers, and produces a quarterly newsletter that is mailed to 800 supporters.

The list of benefits that the Friends have given to South Cumberland is long and impressive. It is impossible to list all the good things that good Friends do for each other. The park's relationship with the Friends is too deep to be put in a letter, but I have attempted to do that here. Our relationship has grown to the point that there is little separation between the Friends and the park. The two are one and South Cumberland would be so much less of a place and so much less valuable to the public if it were not for the support and concern of the Friends.

I would certainly say that the Friends efforts have been and are constantly invaluable to the successful operation of the park. Please contact me if I can offer any further testimony to document the value that the Friends provide to South Cumberland State Park.

DESCRIPTIONS FOR EVAN MEANS GRANT APPLICATION OF 2016 BRIEF HISTORY OF CUMBERLAND TRAILS CONFERENCE (CTC): The history of the CTC is familiar to most TTA members. In 2015 the Conference was reorganized into a nonprofit 501(c)(3) corporation. The purpose of the corporation remains as before, to construct, support and promote the Cumberland Trail project in East Tennessee, through the efforts of paid employees and volunteers and funds raised from private and non-Tennessee State Parks sources.

PROJECT DESCRIPTION: After a long hiatus, the Cumberland Trails Conference reestablished its Big Dig trail-building program in the fall of 2015. The project is to be repeated this year. The work will be directed by a senior trail building assistant, 2 additional paid part-time staff members and a number of volunteers. (Last year there were from 8 or ten to as many as 18 volunteers on a given day). The construction effort will again be devoted to work along Daddy's Creek north of Crab Orchard, TN. Lodging and meals will be provided for staff and volunteers over a 4 week interval in October-November 2016. Funds are required for staff wages, food and lodging, and fuel for equipment (Ditch Witch). Estimated cost is of the order of \$20,000.

WILL OTHER GROUPS BE INVOLVED?: Yes, a modest amount of work will be provided by Cumberland Trail State Park rangers, primarily some trail marking and flagging by ranger Anthony Jones.

OTHER FUNDING SOURCES; The CTC has an organized fund raising effort in support of the 2016 Big Dig. In addition to TTA, grant applications are being made to Middle Tennessee Natural Gas, Wild Trails, American Hiking Society, Community Foundation of Greater Chattanooga, Rock Creek Outfitters, Smokey Mt. Hiking Club, Keen Effect, REI, Cumberland County Bank, and local County Governments (County Commissions). Grant requests fall in the range of \$500 to \$5,000. The 2016 goal for total Big Dig funding is \$20,000 to \$25,000.

MEMORANDUM OF UNDERSTANDING REGARDING POST-CLOSING RELATIONSHIP OF TTA AND CTC

THIS AGREEMENT ("MOU") is made and entered into as of January 1, 2016 (the "Closing Date") by and between TENNESSEE TRAILS ASSOCIATION, INC., a Tennessee nonprofit corporation ("TTA"), and CTC FORMATION GROUP, INC., a Tennessee nonprofit corporation ("CTC").

WITNESSETH:

WHEREAS, TTA is a Tennessee nonprofit, public benefit corporation classified as a public charity under Internal Revenue Code Section 501(c)(3), founded in 1968 to promote the development of a statewide system of hiking trails;

WHEREAS, CTC is a Tennessee nonprofit, public benefit corporation classified as a public charity under Internal Revenue Code Section 501(c)(3), founded in 2015 to (a) serve as an advocate for the Cumberland Trail in Tennessee as a scenic foot trail, (b) provide construction and maintenance support to the Cumberland Trail State Scenic Park (CTSSP), and (c) provide for the conservation of natural resources and promotion of rational development within the counties surrounding the CTSSP, so as to preserve its natural beauty and intrinsic value for posterity;

WHEREAS, CTC was originally an associate organization of TTA operating under its authority;

WHEREAS, in early 2015, recognizing the focused mission of CTC, TTA voted to spin off CTC into a separate corporation;

WHEREAS, CTC was formed pursuant to an Agreement to Form a Corporation entered into between TTA and the Organizers of CTC, for the purpose of assuming responsibility for the operations of the CTC from and after the Closing Date;

WHEREAS, the execution of this MOU is a pre-condition to the transfer of assets from CTC to TTA; and

WHEREAS, the purpose of this MOU is to define the working relationship between TTA and CTC, the manner in which the two organizations have agreed to collaborate, and the general terms and conditions of the parties' relationship;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements contained herein, the parties hereto agree as follows:

1

- Mutual Cooperation. TTA and CTC agree to cooperate in the furtherance of both organizations' mutual goals. Such cooperation will include, but will not be limited to, the following:
- (a) TTA and CTC will work cooperatively to assist each organization in building and recruiting members and volunteers, including but not limited to sharing TTA and CTC membership organizational databases. TTA and CTC will continue to make their respective newsletters, websites, and other media sources available to each other as a shared resource to promote volunteer recruiting, and to advertise outings, programs, and other announcements related to the two organizations' common interests.
- (b) TTA may at its discretion discount membership fees to members of CTC and CTC may at its discretion discount membership fees to members of TTA.
- (c) To the extent that certain future projects require more detail, the terms and conditions of such projects shall be set forth in statements of work that shall be attached to this MOU and deemed incorporated herein.
- 2. Shared Board Positions. TTA and CTC shall each consider amending their bylaws to provide a seat on its board of directors for a representative of the other organization. Once such amendments are in place, it is the intent that TTA appoint one of its board members to serve for a one year term on the board of directors of CTC and CTC appoint one of its board members to serve for a one year term on the board of TTA. TTA and CTC each understand and agree that any member so designated will have the same legal duties as any other director to the organization on whose board he or she serves.
- 3. Use of Names and Logos. This MOU does not authorize either party, without the prior written consent of the other party, to use in advertising, publicity, public communications or otherwise (including, but not limited to, any press releases, sales materials, product literature, web sites, or using the relationship that is established under this MOU for the purpose of soliciting funds from current or potential donors) the name of the other applicable party or its trustees, directors, officers, managers, staff members, employees, students, or agents thereof, or any trade name, trademark, service mark, symbol, or logo, or any abbreviation, contraction or simulation thereof (the "Marks") owned by the other party, without such party's prior written consent. Such consent is hereby given for TTA to use the registered names and logos of CTC, and for CTC to use the registered names and logos of TTA, solely to meet the mutual objectives of the two organizations as provided for under this MOU.
- 4. Grant Proposals. Both TTA and CTC maintain grant programs to other agencies. Recognizing the mutual goals of the two organizations, TTA may submit grant proposals in accordance with the rules of the CTC grant program and CTC may submit grant proposals in accordance with the rules of the TTA grant program. However, no special consideration over other agencies will be given to either organization.

- Fund Raising. TTA and CTC will each support and promote the fund raising efforts of the other.
- 6. Confidentiality. (a) Each party (the "Receiving Party") understands that the other party (the "Disclosing Party") may disclose Confidential Information to the Receiving Party as defined in this Section 6 in connection with the negotiation of and performance under this MOU. "Confidential Information" means (i) all information disclosed in tangible form by the Disclosing Party and marked "confidential" or "proprietary", and (ii) all information disclosed orally or otherwise in intangible form by the Disclosing Party and designated as confidential or proprietary at the time of disclosure.
- (b) The Receiving Party agrees to protect Confidential Information (whether disclosed before or after the Effective Date) from unauthorized use, dissemination or publication by using the same degree of care, but not less than a reasonable degree of care, as the Receiving Party uses to protect its own confidential or proprietary information of a similar nature. The Receiving Party will limit the use of and access to the Disclosing Party's Confidential Information to the Receiving Party's employees or independent contractors who have a demonstrable need to know, who have been notified that such information is Confidential Information and who are under binding obligations of confidentiality no less restrictive than those of this MOU.
- (c) The Receiving Party's obligation to protect Confidential Information under this MOU will expire two (2) years from the date of expiration or termination of this MOU.
- (d) The restrictions set forth in this Section 6 will not apply to any Confidential Information: (i) after it has become generally available to the public through no fault of the Receiving Party or its consultants, agents or subcontractors; (ii) that is rightfully in the Receiving Party's possession before disclosure to the Receiving Party by the Disclosing Party; (iii) is independently developed by the Receiving Party without the developing person(s) having access to the Disclosing Party's Confidential Information; or (iv) is received by the Receiving Party in good faith from a third party not subject to an obligation of confidentiality.
- (e) In addition, the Receiving Party may disclose Confidential Information if required to do so by statute, administrative process or court order, provided that (i) the Receiving Party gives the Disclosing Party sufficient advance notice of such disclosure requirement; (ii) the Receiving Party cooperates with the Disclosing Party, at the expense of the Disclosing Party, in trying to seek a protective order in connection therewith; and (iii) the scope of such disclosure is limited to the extent possible.
- Information and Communication. This collaboration will be coordinated through the offices of the Chairman of CTC and the President of TTA.
- 8. Funding. The parties to this MOU may from time to time jointly seek funding to implement the activities of the collaboration. Potential donors and funding agencies shall be sought through joint efforts to achieve the goals and objectives of this MOU. The parties agree

that, unless otherwise provided for in this MOU, the financial arrangement for any project undertaken under this MOU will be set forth in the applicable Statement of Work for the project.

- 9. Notices. All notices required to be given under this MOU shall be sufficient if given in writing and sent by United States Certified Mail, postage prepaid, return receipt requested, to the appropriate party at the address given below, or at such other address (or addresses) as may be provided by notice given under this section. All notices given pursuant to this MOU shall be effective when mailed. The party giving notice should retain a postmarked Certified Mail Receipt as evidence of the mailing date.
- (a) Notice to CTC Formation Group, Inc. shall be sent to the Principal Office of the Corporation as stated on the records of the Tennessee Secretary of State. That office address is currently as follows (subject to change):

(b) Notice to Tennessee Trails Association shall be sent to the Principal Office of the Corporation as stated on the records of the Tennessee Secretary of State. That office address is currently as follows (subject to change):

- (c) The party giving notice has the burden of confirming the currency of the other party's Principal Office address on the records of the Tennessee Secretary of State.
- 10. Duration; Amendment; Assignment. This MOU is valid for an initial period of five (5) years, commencing on the date of the last signature below. This MOU may not be amended or modified except with the written consent of both parties. Neither party may assign or subcontract its rights or obligations under this MOU in whole or in part without the prior written consent of the other party.
- 11. Termination; Force Majeure. (a) Either party shall be permitted to unilaterally terminate this MOU for any reason, without liability, by giving written notice to the other party not less than ninety (90) days prior to termination. Notwithstanding the foregoing, either party may terminate this MOU at any time upon written notice to the other party if the other party: (a) materially breaches this MOU or the terms of any mutually agreed on Statement of Work, and fails to cure such breach within thirty (30) days after receiving written notice of such breach from the non-breaching party; (ii) ceases to do business in the normal course; or (iii) becomes or is declared insolvent or bankrupt.

- (b) If because of a Force Majeure, either party is unable to perform in whole or in part its obligations as set forth in this MOU, then such party will give the other party prompt written notice of such cause, and will be relieved of those obligations to the extent it is unable to perform for thirty (30) days from the notice date, and thereafter for as long as such cause continues. "Force Majeure" shall mean any earthquake, fire or other acts of God, riot, war, act of terrorism, formal restrictions on travel imposed by a governmental agency, or political instability that, in the reasonable opinion of a party, renders it undesirable to travel to a destination to render services under this MOU. If after thirty (30) days the party affected by such Force Majeure is unable to continue performance, the other party may terminate this MOU pursuant to subsection (a) of this Section 11. Neither party will be liable for any loss, injury, delays or damages suffered or incurred by the other party due to the above causes or to the termination of the MOU pursuant to this subsection 11(b).
- 12. Independent Contractors. Nothing contained in this MOU will be construed as creating any agency, partnership, joint enterprise or other similar relationship between the parties. The relationship between the parties will at all times be that of independent contractors. Neither party will have authority to contract for or bind the other in any manner whatsoever. This MOU confers no rights upon either party except those expressly granted herein, and does not confer any right upon either party to make any representation or commitment on behalf of the other.
- 13. Binding Effect; Assignment. This MOU shall be binding upon and shall inure to the benefit of the respective parties hereto and their successors and permitted assigns.
- Counterparts. This MOU may be executed in any number of counterparts, each of which shall be deemed to be an original.
- 15. Governing Law; Venue. This MOU shall be governed by and construed in accordance with the law of the State of Tennessee. Any litigation brought with respect to this MOU or the transactions contemplated hereby shall be brought in a court of competent jurisdiction in Cumberland County, Tennessee.
- 16. Severability. In the event that any provision of this MOU is declared invalid or unenforceable by any court of competent jurisdiction, such provision shall be deemed severed from this MOU, and the remainder of this MOU shall remain in full force and effect according to its terms.
- 17. Waiver. Any of the terms or conditions of this MOU which may be waived may be waived in writing at any time by any party hereto which is entitled to the benefit thereof.
- 18. Enforcement. The parties hereto agree that the provisions of this MOU and the performance of each party hereunder may be enforced by any right or remedy available at law or in equity, including, but not limited to, the remedy of specific performance.

- 19. Dispute Resolution. (a) Scope. Any controversy, dispute, or disagreement arising out of or relating to this Agreement, or the breach of this Agreement, (referred to in this Section as a "dispute") shall be settled according to the procedure set forth in this Section 19.
- (b) Informal Conference. In the event a dispute arises between or among the parties, each party shall be obligated to meet and confer with the other(s) in good faith, on reasonable notice, and at a mutually agreeable location. The parties agree that if any party refuses to participate in such a conference, or if such a conference fails to produce a mutually acceptable resolution of the dispute within fifteen (15) calendar days after the parties' receipt of notice of the dispute, the other party or parties may submit the matter to mediation or arbitration pursuant to this Section 19
- (c) Mediation. In the event a dispute arises between or among the parties that cannot be settled by informal conference as set forth above, the parties may, on mutual agreement, submit the matter to mediation to be conducted in Cumberland County, Tennessee. The process for selecting the mediator shall be determined by the mutual written consent of the parties. If the parties fail to agree to a process within ten (10) calendar days from a request, the requesting party may proceed to invoke the arbitration process provided for herein. The consent of any party to such mediation may be withdrawn at any time, without cause.
- (d) Arbitration. (i) In the event a dispute cannot be settled by informal conference or mediation as set forth above, or in the event either party refuses or withdraws consent to mediation, the matter shall be settled by arbitration before a single arbitrator in Cumberland County, Tennessee. The process for selecting the arbitrator, and the rules for arbitration, shall be determined by the mutual written consent of the parties. If the parties fail to agree to an arbitrator or the rules for arbitration within ten (10) calendar days after receipt of a demand for arbitration, the arbitration shall proceed in accordance with the American Arbitration Association (AAA) Commercial Arbitration Rules, except as modified below. Judgment on the award rendered by the arbitrator or panel of arbitrators may be entered in any court of competent jurisdiction.
- (ii) Immediately after the filing of the submission or the answering statement or the expiration of the time within which the answering statement is to be filed, the AAA shall send simultaneously to each party to the dispute an identical list of ten (10) (unless the AAA decides that a greater number is appropriate) names of persons chosen from AAA's National Roster of Commercial Arbitrators. The parties will attempt to agree on an arbitrator from the submitted list, and if they are able to do so, they will promptly advise the AAA of their choice. The same person may serve as both mediator and arbitrator only with the consent of all parties.
- (iii) If the parties are unable to agree on an arbitrator within fifteen (15) calendar days of the date the AAA transmitted the list, each party to the dispute shall have an additional seven (7) calendar days in which to strike names objected to, number the remaining names in order of preference, and return the list to the AAA. If a party does not return the list within the time specified, all persons named therein shall be deemed acceptable. From among the persons who have been approved on each party's list, and in accordance with the designated order of mutual

preference, the AAA shall invite the acceptance of one (1) arbitrator to serve. If the parties fail to agree on any of the persons named within the time specified by AAA, or if acceptable arbitrators are unable to act, or if for any other reason the appointment cannot be made from the submitted lists, the AAA shall appoint an arbitrator from among other members of AAA's National Roster of Commercial Arbitrators without the submission of additional lists. The arbitrator selection process set forth above shall apply regardless of whether there are two or more claimants or two or more respondents involved in the dispute.

 (iv) Each party shall bear its own costs and expenses, and an equal share of the arbitrator's fees and administrative fees of arbitration.
