Officer and Committee Reports

Vice-President—Libby Francis

- Libby Francis made a motion to elect Duane Frichtl, Sumner Trails Board Representative, to the position of At-large Director, to fill a vacancy created by the resignation of Mary Etta Ward from the position. Jenny Fitzgerald seconded. Motion carried.
- Mark Hubbard made a motion to elect Duane Frichtl, At-Large Director, to the office of Vice-President, to fill a vacancy created by the election of Libby Francis as President. Jenny Fitzgerald seconded. Motion carried.

Secretary—Melinda Pearson

Melinda Pearson presented the MOM (minutes of the board meeting) for the 4th quarter 2020, and the MOM for the Special Organizational Meeting 2020, and moved to approve them as presented. Bob Oboboski seconded. The secretary will comply with Board's instruction to spell out in words the abbreviation "EMGP" used in the the 4th quarter 2020 MOM. Membership—Cheryl Heckler

Cheryl Heckler presented the Membership Numbers report for the first Qtr. of 2021, and three other reports for February 2021—Membership Listing by Chapter, Recently Joined Members, and Membership Classes by Chapter. (Attachments 11, 12, 13, 14)

The Membership Director reported a great deal of unresponsiveness to her new-member survey. It was therefore suggested & agreed, to move the new-member survey to the administration of the chapters for the rest of the year, with hope of better response.

Grants—Joan Hartvigsen

On behalf of the committee, Joan Hartvigsen presented the following 4 grant applications, and moved to fund them. (Attachments 15, 16, 17, 18, 19)

Patti Deen seconded the motion to fund the Friends of South Cumberland State Park (SP) for \$1470 to purchase equipment and building materials needed to restore a portion of the Foster Falls Climbers Trail. Motion carried. (Attachments 15 & 16)

Jane Ellett moved and Jane Coffey seconded the motion to fund the Friends of Rocky Fork SP for \$ 859.44 to purchase equipment that the Trails Committee will use to continue enhancement and safety of the Park trails. Motion carried. (Attachment 17)

Terry Warren seconded the motion to fund the Friends of Johnsonville State Historic Park for \$750 to print 6,000 copies of updated hiking trail maps. Motion carried. (Attachment 18)

Jane Coffey seconded the motion of Joan Hartvigsen to fund a request of \$ 4000 from Plateau chapter for Uplands Village Retirement Community to build a parking lot and .27 mi. ADA trail at a site on Upland Village property. A roll call vote was taken. Vote on the motion was 7 votes for, 7 votes against, 2 votes to abstain. There being no majority vote for the motion, the motion failed. The grant applicant can reapply. (Attachment 19)

Communications Committee—Website/Newsletter/Facebook.

Doug Burroughs presented an update report on parts of the website, and website training events, completed since the website went live on 12/10/20. Cheryl Heckler presented an update on Members' website login progress.

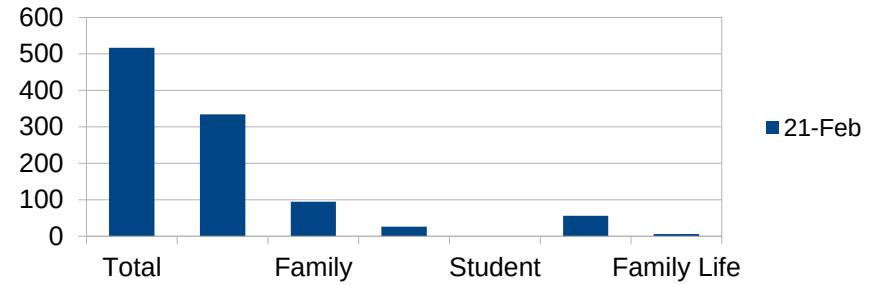

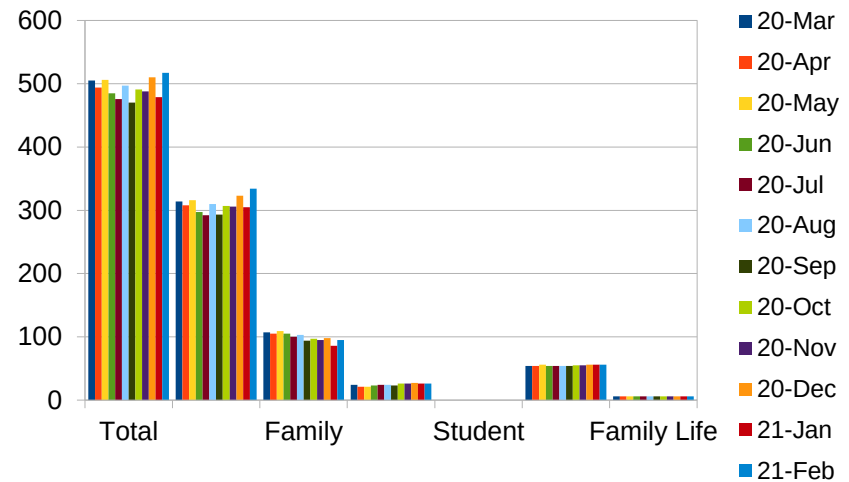

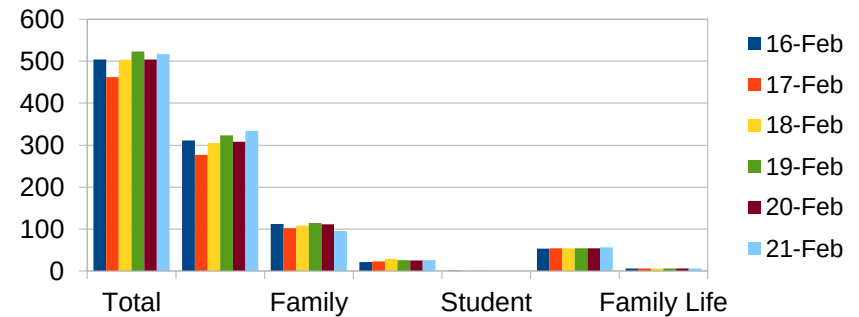

A brief description: South Cumberland State Park (SCSP) is a popular destination for thousands of hikers and campers seeking the wilderness in the outdoors. The SCSP is comprised of over 31,000 acres, contains nearly 100 miles of trails, and 13 primitive campgrounds. The Friends of the South Cumberland (FSC) wish to restore the entry platform to "Plunge pool" portion of the Foster Falls Climbers Trail. Due to age, heavy visitor use, and water erosion, this portion of the trail, including the entry platform and rocky terrain, have become extremely difficult and dangerous to navigate. This first phase will be completely replacing and extending the entrance platform and stairway. FSC is requesting Evan Means grant funding of \$1,470 to procure tools and building materials to complete the project, as per the attached spreadsheet list. The sturdy new installation will utilize large timbers attached to the sandstone bluff and consist of a platform structure with a bridge staircase. This will enable visitors to safely descend the steep rocky section on a sturdy wider platform.

How does it fit? : – The FSC Trails Committee's primary goal is to help assure SCSP trails provide safe access for park visitors and see that trails are built in a sustainable manner, using best practices which minimize future maintenance and remediation. FSC Trails Committee also works with Park Managers and Rangers to monitor and document existing trail conditions, prioritize recommendations for remediation, and facilitate trail solutions; and to facilitate the design and construction of new trail as directed by Park Managers.

How will hikers benefit? : The Foster Falls plunge pool platform and stairway will provide safer access to wilderness hiking and camping destinations within the Fiery Gizzard area of SCSP. Importantly, it will provide improved emergency access for park rangers search and rescue, as well as improved visitors access to swimming, rock climbing, and spectacular rock formations, wildlife and waterfalls.

When is the project expected to begin? : The project is expected to begin Feb-1-2021.

When is the project expected to be completed? The project is expected to be completed by Mar-1-2021

Project Description:

Any trail work and maintenance has been done primarily with committee members own personal tools and equipment.

Narrative description of hikers benefit from the project

As the newest state park to Tennessee the Park remains in a wilderness stage without a visitor's center, permanent restroom facilities, or enhanced accessories for hikers. Hiking remains the primary activity of this Park. The beautiful surroundings, history, and varied trails are what draw people to the Park and the conditions of the trails must be maintained for safety. The ongoing pandemic has brought citizens out to the Parks throughout Tennessee. An increase of 175% usage has been recognized as a result. Maintaining these trails is essential to the continued use of the Park by the visitors as well as for their safety. Having equipment available for members allows immediate access when needed, eliminating time delays and negate the use of their own personal property.

A brief description of the project for which funding is being sought:

The Friends of Johnsonville State Historic Park would like to request \$750 to obtain 6,000 copies of updated hiking trail maps. Over the last several years, park staff and volunteers have worked to add, re-route, and correct many sections of hiking trails within the park. Through making these changes, existing hiking trail maps have become outdated. Park staff has worked to record GPS tracks of the trails and coordinate with GIS specialists within Tennessee State Parks to depict the current state of hiking trails at Johnsonville. With the help of TTA, trail maps would be available for all visitors who come to Johnsonville. This project promotes the system of hiking trails within the State of Tennessee, meeting mutual goals between Tennessee State Parks and Tennessee Trails Association.

How does this project fit within the range of your organization's total activities?

At Johnsonville State Historic Park, we work to preserve, protect, and share the stories of Johnsonville. Additionally, our park strives toward the mission statement of Tennessee State Parks, which is, "To preserve and protect, in perpetuity, unique examples of natural, cultural, and scenic areas and provide a variety of safe, quality, outdoor experiences through a well planned and professionally managed system of state parks." Our hiking trails lead visitors along corridor that traces through the history and natural environment of Johnsonville. Johnsonville, TN was the site of a Federal supply depot, transporting goods for the Union forces throughout the south, during the late Civil War. On November 4, 1864 the Battle of Johnsonville took place along the banks of the Tennessee River, and shortly after the war ended, the military history transitioned into the town history of Johnsonville. The town existed from 1865- 1944, when the TN River channel was dammed to create Kentucky Lake Reservoir, displacing the community. Today, just as people once called Johnsonville home, now plants and wildlife call the park home.

When looking back at the mission statement of TN State Parks, this project allows for a well planned approach of sharing the stories of the park, while also providing a safe experience in the outdoors. The park is a location where visitors can enjoy their natural and cultural environments. At Johnsonville, visitors can follow trail maps that will guide them along historic roadbeds, 100+ year old cemeteries, Civil War earthworks, and town era homesites, all while being surrounded by wildlife and preserved natural habitat.

Explain how hikers will benefit from the project:

Hikers will benefit from this project through a clear understanding of where trails are located at Johnsonville State Historic Park. With the updated trail maps, new re-routes will be clearly marked by not only blazes, but also by GIS tracked mapping. When stopping at the Visitor Center, hikers will have the option to pick up a trail map, depicting 4 well marked trails (Historic Johnsonville Trail, Civil War Forts Trail, African-Methodist Cemetery Loop Trail, and Old Railway) , as well as multiple points of interest (Redoubt Fortifications, Cemeteries, Train Turntable, Soldier Huts, Rifle Pits, etc.) throughout the park. The maps will help guide hikers in the correct direction and reduce their risk for becoming lost while enjoying both the natural and cultural resources that Johnsonville State Historic Park has to offer. Beyond the clarity in trail location, the interpretation of the site is improved through the map. The maps provide an aerial vantage point of the historic resources and their relation to the railroad and original river channel, further connecting hikers with the culture of Johnsonville.

When is the project expected to begin?

This project is expected to begin during the month of March, 2021. Trail updates have been logged and are currently being added to digital maps. Once funds have been received, the process of purchasing the new maps can begin.

When is the project expected to be completed?

This project is expected to be completed no later than December 31st, 2021.

What is the total cost of this project from all sources?

Total Cost: \$750

Provide a detailed spending plan for the amount being requested from TTA:

The cost for 20 pads at 13.5"x17" is approx. \$250. There are 100 sheets per pad. We would like to purchase 3 orders of this amount, resulting in 60 pads and 6,000 trail maps, at a total value of \$750.

Funds will be received by Friends of Johnsonville State Historic Park and deposited into their bank account. The \$750 will then be applied to the Johnsonville State Historic Park donations account, by way of a debit card transaction. After the donation has been captured within the parks budget, those funds will then be used to purchase the trail maps from the Marketing office within Tennessee State Parks.

Above, you will find volunteer hours for Johnsonville State Historic Park during Fiscal Year 2020. Under the event titled, "University of Missouri- Columbia", you may notice that most of the volunteer hours logged were from this group. We were able to partner with an alternative break group from this University, which brought 11 college students to our park during fall break. Within the 154 volunteer hours logged, 33 of those hours were spent directly improving trail corridor on the Civil- War Forts trail within the Park. This work involved trimming encroaching vegetation, cutting back cuts, and removing berms from the out slope of the trail tread. The U. of Missouri- Columbia also worked at removing invasive species surrounding an historic homesite that is located along our Historic Johnsonville Trail. Clearing the site of invasive species makes the space more accessible for hikers who visit the park, allowing them to interact with the historical resources that exist today.

A brief description of the project for which funding is being sought: To construct a walking trail that will support senior citizens who are capable of walking at least ¼ mile on compacted gravel surfaces. The proposed trail is .27 miles in length with some slight elevation changes. It is hoped that the ease of access, and the trail being purposefully designed to accommodate walkers with disabilities, will attract people with limited mobility. Walkers will access the trail at Yonside Drive, immediately across from a semi – improved parking area that will be part of this project. The parking lot will be 40' x 20' making provision for 3 handicap spaces. Parking area is needed for the hikers to be able to park within a reasonable distance to the trailhead. This additional parking area is adjacent to the parking area for the Lake Alice trail that was part of the Cumberland County Hiking Marathon. The trail will be built roughly to the specifications shown in the attached drawing and will go from Yonside Drive to near the shore of Lake Laura.

There are no plans to request funds for future trails and all work done on this trail will be accomplished by Uplands Village staff and other volunteers. Prior activities such as building a bridge, 3 trail kiosks, and 3 benches have been supported by the local Boy Scout Eagle Projects. Two boardwalks were built and donated by a church youth group, and 5 bridges were built by residents of Uplands Village using their own resources. This trail, to be ADA compliant, requires more resources than available from previous donors and is a good fit for support by an Evan Means Grant, with the Plateau Chapter overseeing the project's completion.

How does this project fit within the range of your organization's total activities? As a chapter within the Tennessee Trails Association's network, our activities support promoting and developing hiking trails throughout the state. This particular project will provide a hiking trail to be used predominantly by people with limited mobility who want to hike but cannot negotiate more remote and difficult trails. Some expected participants, while self – sufficient in caring for themselves may be using walkers, canes, and some may even be wheel chair bound. This trail will be surfaced so that people in need of special assistance to maintain mobility can do so and enjoy the outdoors environment that this area provides them.

For the record, all of the Uplands Village trails are open and accessible to the general public and people can and do show up unannounced to walk them. The Lake Alice Trail and the Adshead Wilderness trail, a short historical trail, are frequented by the local community on an increasing basis. In summary, this proposed trail will expand promotional efforts about hiking for people of any age.

Uplands Village has a history of making good use of Evan Means grant money, outlined below.

- 2014, \$600.00 for trail tools.
- 2015, \$250.00 for trail markers.

- 2017, \$600.00 for 2 bridges on the Lake Alice Trail.

Recognition of the Tennessee Trails Association's support has been publicized in the Uplands Newsletter and the Crossville Chronicle, circulated throughout Cumberland County.

Explain how hikers will benefit from the project: Uplands Village is a 501c3 nonprofit organization with limited funding for capital improvements of this nature. It draws on its' own operational funds and depends to some extent on private donations to provide recreational areas for people with limited mobility. Documentation of this status can be provided if needed. Donations, this year have been adversely impacted by the ongoing COVID-19 pandemic. Building this trail will allow hikers of all ages and abilities to interact with each other. It will encourage young families, who engage in hiking, to visit their elder family members, who may have retired to the upper Cumberland area, and collectively enjoy a Tennessee trail. It will encourage people with limited mobility to enjoy nature and the outdoors. This trail will give everyone a chance for an "outdoors experience" without the stress or concern that the trail will be too much for the older members in the group. For that matter, the younger people who may be bringing toddlers or infants with them can do so without the worry that they will have to exclude someone to stay behind with the youngsters.

When is the project expected to begin? The project could begin within 30 days from the receipt of funds, as personnel and necessary equipment for grading and surfacing the trail are on site. This also goes with the understanding that the weather has to cooperate so rough grading can take place.

When is the project expected to be completed? This trail could be completed within 60 – 90 days from the start date so long as expected staff and volunteers are available to do the work. Progress and keeping on schedule will all be weather dependent to some extent.

What is the total cost of this project from all sources? Estimated cost of the completed trail and the supporting parking area is shown below.

1. Fill Dirt – to bring low spots up to desired grade – 10 Loads @ \$200.00 per load = \$2,000.00
2. Crushed Rock – Trail only to establish a compacted base – 3 Loads/total cost = \$1,000.00
3. Crushed Rock to establish base for parking lot – 3 Loads/total cost = \$1,000.00

Estimated total cost of project \$4,000.00. Some variance may be experienced based on final grading and results of compacting, which could reduce the amount of material needed.

To summarize, material cost for the trail alone is \$3,000.00 broken out as \$2,000.00 for fill dirt and \$1,000.00 for crushed rock. This material will support construction of the .27-mile trail and allow for future plans to add sections to connect to an existing trail and even for future trails, not yet planned.

Provide a detailed spending plan for the amount being requested from TTA: Within 10 days of being informed that requested funds have been approved, Uplands Village staff will begin rough grading the intended trail and parking area as shown in the attached diagram. **No Cost.** Upon completion of rough grading fill dirt will be ordered and designated areas requiring fill will be covered and graded. Compacting will be done in trail area and proposed parking area. **\$2,000.00 for material only...** with grading and compacting machinery provided through Uplands Village. Time required estimated at 10 working days. Upon completion of base dirt being compacted crushed rock will be ordered. Delivery will be contingent upon material availability. Once received, rock will be distributed over trail and proposed parking area and compacted to form a solid base. Requested delivery will be staggered to

allow for sufficient settling and compacting of dirt and rock. **\$1,000.00 for material only**...machinery and labor provided by Uplands Village. Time for this phase estimated at 10 working days. Final surface gravel will be ordered once rock compacting has settled. Estimate 3 days between each load so as to spread, compact and settle **\$1,000.00 for material only**...again, machinery and labor provided by Uplands Village staff with assistance from Plateau Chapter by people with trail maintenance experience.

How many total man-hours will be required for the project? Estimated man-hours: 4 people x 20 hours per week x 3 weeks = **240 hours**. Estimates subject to change based on staff time available from Uplands Village.

How many volunteer hours are expected to be used for the project? The estimate of 240 hours is from staff time at Uplands Village. In addition; Plateau Chapter volunteers: 3 people x 6 hours per week for 3 weeks = 54 hours. **Total volunteer hours: 294**
