Evan Means Grants Committee—Joan Hartvigsen

Joan Hartvigsen reported on each of 7 Evan Means grant requests that were received this quarter. (Attachments 10, 11, 12, 13, 14, 15, 16).

On behalf of the Grants committee, Joan Hartvigsen made a motion (2nd Patty Deen) to fund the requests as follows: \$1000 Friends of Mousetail Landing State Park; \$2675 for Friends of Natchez Trace State Park; \$1000 for Sergeant York Patriotic Foundation; \$2000 for TTA Plateau Chapter on behalf of Uplands Village Retirement Community; \$813.85 for Friends of Long Hunter State Park; \$0 for Friends of Rocky Fork State Park; \$0 for Friends of Edgar Evans State Park. (Attachment 17) Motion carried with Terry Warren and Cheryl Heckler abstaining for conflict of interest.

Outreach Committee - Norm Brinsley

Norm Brinsley, Committee chair, reported on TTA's updated Booth Display, participation in 50th Anniversary Celebration of the Cumberland Trail, and ways the committee intends to help promote TTA in print media.

Committee member Libby Francis made a motion (2nd Terry Warren) to fund a Silver Level annual membership in the American Hiking Society, currently costing \$200/year. Motion carried.

Libby reported the committee's recommendation to join the Mack Pritchard Foundation for \$100, and so moved (2nd Dwayne Frichtl). Following discussion, Libby amended the motion (2nd Dwayne Frichtl), moving to make a 2021 donation to the Mack Pritchard Foundation in the amount of \$100. Motion carried.

Awards Committee - Duane Frichtl

Committee Chairman Duane Frichtl presented the report, and made a motion (2nd Joan Hartvigsen) the that the 2021 budget for his committee be increased from \$150 to \$300 for purchasing additional awards, as the committee hopes to present a double set of awards—retroactively for 2020 (when no awards were given), and currently for 2021. Doug Burroughs, chairman of Meeting host chapter Nashville, reported progress of the planning committee for the TTA Annual Conference in Oct. 2021. 
Duane Frichtl made a motion (2nd Mark Hubbard) to adjourn the meeting at 7:32pm. Motion carried.





The Evan Means Grant Committee and other TTA members participated in Evan Means Grant presentations this quarter. Susan Wood, TTA Board Member and Jackson Chapter member, presented a Evan Means Grant to the Friends of Johnsonville State Historic Park for updated hiking trail maps. Terry McCoy Warren, Jackson TTA Chapter member and TTA Board Member, presented the Evan Means Grant to the Friends of Natchez Trace State Park. This Grant provides funds for a heavy duty tilting bucket designed for trail building. Committee members Libby Francis and Joan Hartvigsen travelled to Uplands Village in Crossville to participate in the Evan Means Grant photo opportunity with the Plateau Chapter, including Cheryl Heckler and Norm Brinsley. This Grant is for a ADA Trail at Uplands Village. Committee members Libby Francis, Mark Hubbard, Marvin Caine and Joan Hartvigsen attended the Evan Means Grant presentation to the Friends of Long Hunter State Park for improvements of the Bryant Grove Trail.

Committee members Mark Hubbard and Joan Hartvigsen and TTA members of the Soddy-Daisy, Sumner Trails, Highland Rim, Murfreesboro and Nashville Chapters met the Friends of Mousetail Landing State Park for a fun weekend of camping, kayaking and hiking at Mousetail Landing State Park, along with the Evan Means Grant presentation. The Grant is for restoration of the Eagle Point Trail damaged by a tornado and flood. The President of the Friends of Mousetail Landing State Park took us on a hike on the Eagle Point Loop Trail.

The Friends of South Cumberland Trail completed the Foster Falls trail project and the Mile Marker project. Libby Francis, Joan Hartvigsen and Marietta Poteet attended the check presentation for Foster Falls trail renovation. Joan and Marietta Poteet attended the check presentation for the Mile Marker project.

The Friends of Henry Horton proudly showed us the bridges and stairs on the new Spring Creek Trail funded by a Evan Means Grant. The Friends then took us on a hike on the Spring Creek Trail. TTA members attending were Joan Hartvigsen, Sara Pollard and Patty Deen. The Friends are also proud of the trailhead sign thanking TTA.
