## Evan Means Grant Program—Joan Hartvigsen

The committee recommends funding six requests. Accordingly, Joan Hartvigsen moved (2nd Jenny Fitzgerald) to fund the following grant applicants: Bays Mountain Park Association (\$767), Bledsoe's Lick Historical Association (\$1,150), Friends of Cummins Falls State Park (\$982.34), Friends of Henry Horton State Park (\$1,000), Friends of South Cumberland State Park (\$885), and Southern Appalachian Highlands Conservancy (\$1,307). Motion carried.

The committee recommends declining the grant request from The City of Tullahoma, TN Tree Board, as their organization and their project, do not qualify for Evans Means Grant funding. No action taken.

Committee member Mark Hubbard said the committee will be accepting grant requests for consideration in the second quarter of 2022.

## EVAN MEANS GRANT COMMITTEE REPORT

## FRIENDS OF NATHAN BEDFORD FORREST STATE PARK (NBFSP) REQUEST

The committee received only one request this quarter for a grant thru Tennessee Trails Association. The request was due to the tornado damage In Benton County in March 2020 to the trails at NBFSP. The tornado completely eradicated some trails and claimed much damage to others (17 miles of trails overall). After the paths were cleared and repaired, they needed new maps and signage to reflect the changes. The Friends of NBFSP requested a grant of \$1,260 for 30 metal signs (12" x 18") at 12 trail intersections and blowdown areas to assist the hikers on the refurbished trails. According to the Friends group, hikers became confused and disoriented because the old signage did not match the new and/or rerouted trails. They reprinted maps of the newly renamed trails from their own funds, and they only requested a grant for the metal directional signs.

The Friends of NBFSP will also use refurbished wooden posts claimed from the Tennessee Department of Transportation (TDOT). They will work with Park Rangers and volunteers to repost the new signs and distribute the new maps. The volunteers have spent >45 hours thus far on this project and feel they will have at least 40 hours of work for the new signage reposting. An example of the signage is at the bottom of this page.

The Friends of NBFSP will acknowledge the support of TTA by placing a sign (at their cost) on the most heavily trafficked trailhead in the Nathan Bedford Forrest State Park. They will also place an announcement in the local newspaper of the TTA support for this project.

The EMG Committee recommends granting the request of \$1,260.00 to the Friends of Nathan Bedford Forrest State Park for this project. *Full grant application available upon request*.

# Insurance Committee Meeting 3/30/2022 6pm via Zoom

The meeting was called to order by Duane Frichtl, committee chair at 6pm. Committee members present were Libby Francis, Jane Coffey, Jenny Fitzgerald, Wendy Porter, and LouAnn Partington. There was a discussion of the quotes received and the need for General Liability insurance and Director's and Officer's insurance. It was the consensus of the committee that the Board should buy both types of insurance. An estimate of the annual cost for these policies would be \$1300 annually.

## **General Liability Insurance Covers**

- \* Protects TTA assets against claims because of injuries during TTA hikes. We have had hikers injured or killed in the past.
- \* Personal autos used during TTA events.
- \* Defense costs even if suit is frivolous.

## Why TTA Needs General Liability Insurance

- \* More lawsuits today than ever before.
- \* Lawsuits are sometimes filed against every organization involved even if later dismissed.
- \* Hiker is injured for life and needs ongoing care that their family cannot afford.
- \* One lawsuit could bankrupt TTA. It is the Board's responsibility to protect the mission, reputation and assets of TTA.

## What Director's & Officer's Insurance Covers

- \* Board as a whole and individuals serving on the Board against lawsuits concerning actions of the Board.
- \* If member alleges the Board as a whole, or an individual of the Board, is not acting in good faith.
- \* Attorney fees even if suit is dismissed as not legitimate.


## Why TTA Needs Director's & Officer's Insurance

- \* Board is a group of individuals making decisions on behalf of others.
- \* Individual Board Members can be sued putting their personal assets at risk.
- \* Personal Umbrella policies usually do not cover service on a non-profit board.


