Dec. 13, 10 a.m. EST, Board meeting, Gray Badger Inn, Kingston Dec. 20, 9:30 a.m. EST, Hike on South Section, Cumberland Trail, Sam Powell leader.

Attendance at the annual maeting on Nov. 15 was light. All enjoyed Faul Adams' slides and report of the 50th anniversary of the Mt. LeConte camp. Joe Gaines reported that work continues on the Chickasaw Bluffs Tail in Fort Pillow and Menman-Shelby State Parks. The bill to remove that trail from the State system is still pending in the General Assembly.

Opposition to the Obed Wild River project has affected work on the Cumberland Trail in Cumberland Co. A little work was done between Cove Lake and Lake City this year. Sam Towell missed the annual meeting to direct a crew fabricating a bridge for the

South section near Signal Mountain.

Stan Gorin reported some work on mapping the Trail of Tears in the McMinnville area. A Federal Task Force has completed a study of the Natchez Trace National Scenic Trail. This would be a multiple use toute, providing for horseback, bike and hiking trails within the corridor of the Natchez Trace Parkway.

The Dept. of Conservation and TVA are studying a plan to acquire two abandoned railways to be used as trails. One, from DeArmond to Petros, could be part of the John M ir Trail. The other would provide needed trail facilities near Dickson. Mack Prichard is working to get the Eastern John Muir Trail included in the National Trails System. The Dept. of Conservation is drawing up proposed legislation to provide for State patrols on trails built by TTA and similar groups.

The annual meeting closed with a dedication hike on the new

backpacking trail in Fall Creek Falls State Park.

The officers for 1976 are Grimes G, Slaughter, Oak Ridge, president; David Rhyne, Cleveland, vice-president; Evelyn Tretter, Goodlettsville, recording secretary; Dot Lingerfelt, Chattanooga, corresponding secretary-treasurer; Gordon Newland, Kingsport, director for 3-year term, and Wm. T. Stutz, Chatta-nooga, filling the unexpired term of David Rhyne. Holdover directors are Donald Todd, Sr., Wartburg, and E. W. Means, re-

tiring president. The Nashville chapter of TTA was formally organized Nov. 7 at Cheekwood, Jim Whittle who runs a backpacking supply store at 4004 Hillsboro Road is the chairman, which automatically

nakes him a member of the Board of Directors.

President-elect's message: "I wish to express a "Well Done" to the TTA officers of this year. They reacted to the total coblapse of capital money support from the current State Administration in a very positive way. The most important move was to incorporate TTA to enable us to enter agreements with landowners. If this dearth of support is going to continue for another three years, then TTA must attempt to compensate. Historically, most of the trail building has been done with youth power, through the good graces of the Boy Scout organization. John McIntyre built many miles of trail with squads of non-voters, and Sam Powell is doing good work on the south end of the Cumberland Trail, using the same talents which John evidently possessed.

"We need to get more scoutmasters and troops interested and enthused, and give them copies of the Trail Construction Manual. Some of the sections may not be built to full David Rhyne standards, but that could come later. We can capitalize on the Bi-centennial Year plan to "Give a day for Trail Construction". (I know it says an Hour instead of Day but we can do better.)
I have gotten very positive responses from many people concernparticipation in such a plan. In '76 let's see how many people we can enthuse, shame, or blackmail into working on trails."
